DECLARATION OF LISA SIEGEL

I, Lisa Siegel, declare as follows:

1. I reside in the City and County of Los Angeles.

2. On September 25, 2010, I went to the Harbor Community Police Station in San Pedro to apply for a carry concealed weapons license.

3. When I asked the officer at the station for an application, he asked if I was a business owner. I replied that I was not a business owner. The officer responded that the LAPD only issues carry concealed weapons licenses to dignitaries, political figures, and high profile celebrities. He told me that any normal citizen never gets approved. He explained that is why the Harbor Community Police Station does not have any carry concealed weapons license applications.

4. The officer gave me two phone numbers to call to request a carry concealed weapons license application, (213) 485-3202 and (213) 485-8081. He said I could call the numbers Monday through Friday and one of them was the number for permit processing. The officer then reiterated that the LAPD never approves a carry concealed weapons license to a normal citizen.

5. I left the Harbor Community Police Station without a carry concealed weapon license application or a copy of the LAPD's carry concealed weapons policy.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct. If called to testify, I would testify to the above facts.
