20 **I. INTRODUCTION**

21 Defendants Eric Holder and Robert Mueller hereby submit their Reply to plaintiffs' Opposition
22 to defendants' Motion to Dismiss this action pursuant to Fed. R. Civ. P.12(b)(1) and (b)(6).
23

II. DISCUSSION

24 **A. 18 U.S.C. § 925A**

25 As discussed in the Motion to Dismiss, it is not clear what jurisdictional basis the plaintiffs are
26 relying on in support of their request for a declaration that their convictions are not misdemeanor
27 crimes of domestic violence within the meaning of 18 U.S.C. § 921(a)(33)(B)(ii). The only statute
28 mentioned in the First Amended Complaint that could conceivably provide such jurisdiction is 18

1 U.S.C. § 925A. The Declaratory Judgment Act, 28 U.S.C. § 2201-02, does not by itself confer federal
2 subject matter jurisdiction. *See Nationwide Mut. Ins. Co. v. Liberatoro*, 408 F.3d 1158, 1161 (9th Cir.
3 2005).

4 Under 18 U.S.C. § 925A, any person denied a firearm purchase pursuant to 18 U.S.C. § 922(s)
5 or (t) and who is not prohibited from receipt of a firearm pursuant to 18 U.S.C. § 922(g) or (n) “may
6 bring an action against the State or political subdivision responsible for providing the erroneous
7 information, or responsible for denying the transfer, or against the United States, as the case may be,
8 for an order directing that the erroneous information be corrected or that the transfer be approved, as
9 the case may be.” 18 U.S.C. § 925A.

10 In the First Amended Complaint, only plaintiff Richard Enos alleges that he was denied a
11 firearm purchase, as is required under 18 U.S.C. § 925A. *See* First Amended Complaint ¶ 29i (“In
12 August of 2004, Plaintiff RICHARD ENOS was denied a firearm purchase and advised by the State of
13 California that the denial was being maintained by U.S. Department of Justice, Federal Bureau of
14 Investigation, National Instant Criminal Background Check System.”). In their Opposition to the
15 Motion to Dismiss, defendants assert that William Edwards has also been denied a firearm purchase.
16 *See* Opposition at 4 n.2. Accordingly, only Enos and Edwards can be viewed as having properly
17 invoked the Court’s jurisdiction under 18 U.S.C. § 925A and the Court lacks jurisdiction to review the
18 other plaintiffs’ requests for declaratory relief that their convictions are not misdemeanor crimes of
19 domestic violence.

20 **B. Plaintiffs’ Convictions Are Misdemeanor Crimes Of Domestic Violence**

21 Assuming for purposes of argument that all of the plaintiffs have properly invoked the Court’s
22 jurisdiction under 18 U.S.C. § 925A, plaintiffs’ contention that their convictions should not be
23 interpreted as misdemeanor crimes of domestic violence under 18 U.S.C. § 921(a)(33)(B)(ii), lacks
24 merit.

25 1. California Penal Code § 12021(c)(1)

26 In their Opposition, plaintiffs do not appear to pursue their arguments that: (1) because they
27 (with the exception of plaintiff William Edwards) have obtained relief under California Penal Code §
28 1203.4, their convictions have been expunged or set aside within the meaning of 18 U.S.C. §

1 921(a)(33)(B)(ii); (2) because a judge in an unspecified Superior Court in California granted Plaintiff
2 Jeff Loughran's motion to vacate his conviction under California Penal Code § 242 for battery pursuant
3 to a writ of *coram nobis* on November 23, 1998, he should not be considered to have sustained a
4 conviction for a misdemeanor crime of domestic violence within the meaning of 18 U.S.C. §
5 921(a)(33)(B)(ii); and (3) because Plaintiff Richard Enos has received relief from the prohibition on
6 firearms possession imposed by California Penal Code § 12021(c)(1) by a superior court judge under
7 California Penal Code § 12021(c)(3), he should not be considered to have been convicted of a
8 misdemeanor crime of domestic violence within the meaning of 18 U.S.C. § 921(a)(33)(B)(ii). *See*
9 Plaintiffs' Opposition ¶¶ 7-8.

10 Instead, plaintiffs focus on their contention that because California does not prohibit them from
11 possessing firearms due to the passage of 10 years since the dates of their convictions under California
12 Penal Code § 12021(c)(1), they should not be considered to have been convicted of misdemeanor
13 crimes of domestic violence within the meaning of 18 U.S.C. § 921(a)(33)(B)(ii).¹ *See* Plaintiffs'
14 Opposition ¶ 9 ("The critical (and undisputed) fact in this case, a fact shared by all Plaintiffs except
15 EDWARDS, is (1) that the State of California, under Penal Code § 12021, took away these Plaintiffs
16 "right to keep and bear arms" for a specific and determinant period of ten years upon their convictions
17 for a MCDV and (2) that ten years have elapsed since those convictions."). As discussed in the Motion
18 to Dismiss, however, this contention lacks merit. Plaintiffs believe that because they may possess a
19 firearm without running afoul of California Penal Code § 12021(c)(1), they have had their "civil rights
20 restored" within the meaning of 18 U.S.C. § 921(a)(33)(B)(ii). This is incorrect for two related
21 reasons.

22 First, "the words 'civil rights restored' do not cover a person whose civil rights were never
23 taken away." *Logan v. United States*, 552 U.S. 23, 36 (2007). Plaintiffs do not allege, nor could they,
24 that their civil rights were taken away when they were convicted of misdemeanor crimes of domestic

26 ¹California Penal Code § 12021(c)(1) provides that a person who has been convicted of certain
27 misdemeanor violations, including under California Penal Code §§ 243 and 273.5, and who, within 10
28 years of the conviction, owns, purchases, receives, or has in his or her possession or under his or her
custody or control, any firearm is guilty of a public offense, which shall be punishable by imprisonment
in a county jail not exceeding one year or in the state prison, by a fine not exceeding one thousand
dollars (\$1,000), or by both that imprisonment and fine. *See* Cal. Penal Code § 12021(c)(1).

1 violence. “The term ‘civil rights’ denotes ‘those rights accorded to an individual by virtue of his
2 citizenship in a particular state,’ comprising the rights to vote, to hold public office, and to serve on a
3 jury.” *Metzger v. United States*, 3 F.3d 756, 758 (4th Cir. 1993) (“The term ‘civil rights’ denotes ‘those
4 rights accorded to an individual by virtue of his citizenship in a particular state’ comprising the rights
5 to vote, to hold public office, and to serve on a jury.”); *McGrath v. United States*, 60 F.3d 1005 (2d Cir.
6 1995) (same); *United States v. Cassidy*, 899 F.2d 543, 549 (6th Cir. 1990) (same). In California, as in
7 most states, a conviction for a misdemeanor does not result in the loss of civil rights. *See People v.*
8 *Haendiges*, 191 Cal. Rptr. 785, 798 n.2 (Cal. Ct. App. 1983); *People v. Murray*, 29 Cal. Rptr. 2d 42, 46
9 (Cal. Ct. App. 1994).

10 Second, the fact that a state has restored an individual’s right to possess firearms is not enough
11 to establish that one’s civil rights have been restored. *See United States v. Valerio*, 441 F.3d 837, 842-
12 43 (9th Cir. 2006); *United States v. Brailey*, 408 F.3d 609 (9th Cir. 2005); *United States v. Andaverde*, 64
13 F.3d 1305, 1309 (9th Cir. 1995). The Ninth Circuit’s decision in *United States v. Brailey*, 408 F.3d 609
14 (9th Cir. 2005), is almost directly on point. There, the plaintiff was convicted of a misdemeanor crime
15 of domestic violence, but he argued that he came within the exception to 18 U.S.C. § 922(g)(9) for
16 persons who have had their “civil rights restored” within the meaning of 18 U.S.C. § 921(a)(33)(B)(ii).
17 *See id.* at 610. He claimed that his civil rights had been “restored” because the Utah statutes, as
18 amended in 2000, provided that persons convicted of misdemeanors are no longer prevented from
19 possessing a firearm under Utah state law. *See id.* at 610-11. The Ninth Circuit rejected this claim,
20 holding that “[b]ecause Brailey’s misdemeanor conviction did not remove Brailey’s core civil rights of
21 voting, serving as a jury, or holding public office, his civil rights have not been ‘restored’ within the
22 meaning of federal law by Utah’s 2000 amendment permitting him to possess a firearm.” *Id.* at 613.

23 While plaintiffs point out that *Logan*, *Valerio*, *Brailey*, and *Andaverde* were all decided prior to
24 *District of Columbia v. Heller*, 554 U.S. 570 (2008), this fact does not aid their argument. Even if the
25 right to bear arms recognized under *Heller* should be viewed as a “civil right” which has been restored
26 to them within the meaning of 18 U.S.C. § 921(a)(33)(B)(ii), plaintiffs do not contend that the other
27 civil rights that § 921(a)(33)(B)(ii) clearly contemplates — rights to vote, to sit on a jury, and to hold
28 public office – were taken away from them and then restored. Accordingly, plaintiffs’ argument that

1 their civil rights have been restored by virtue of California Penal Code § 12021(c)(1) lacks merit.

2 2. Disturbing the Peace Under California Penal Code § 415

3 In his Opposition, Plaintiff Edwards continues to assert that his conviction under California
4 Penal Code § 415 is not a misdemeanor crime of domestic violence within the meaning of 18 U.S.C. §
5 921(a)(33)(A) because it does not have as an element, “the use or attempted use of physical force, or
6 the threatened use of a deadly weapon, committed by a current or former spouse, parent, or guardian of
7 the victim, by a person with whom the victim shares a child in common, by a person who is cohabiting
8 with or has cohabited with the victim as a spouse, parent, or guardian, or by a person similarly situated
9 to a spouse, parent, or guardian of the victim.” 18 U.S.C. § 921(a)(33)(A)(ii); First Amended
10 Complaint ¶¶ 33, 46-48.

11 As discussed in the Motion to Dismiss, to the extent Edwards is asserting that California Penal
12 Code § 415 must include as an element that the victim share one of the domestic relationships specified
13 in 18 U.S.C. § 921(a)(33)(A)(ii) in order to constitute a misdemeanor crime of domestic violence, that
14 argument was rejected in *United States v. Belless*, 338 F.3d 1063, 1066 (9th Cir. 2003) (“The federal
15 statute does not require that the misdemeanor statute charge a domestic relationship as an element. It
16 requires only that the misdemeanor have been committed against a person who was in one of the
17 specified domestic relationships.”); *see also United States v. Hayes*, 555 U.S. 415, ___, 129 S. Ct. 1079,
18 1087 (2009) (same).

19 To the extent Edwards is asserting that California Penal Code § 415 does not include, as an
20 element, “the use or attempted use of physical force, or the threatened use of a deadly weapon,” this is
21 not true. First Amended Complaint ¶ 47. Edwards did not specify in the First Amended Complaint
22 which provision of California Penal Code § 415 he was convicted of. California Penal Code § 415(1)
23 covers “[a]ny person who unlawfully fights in a public place or challenges another person in a public
24 place to fight.” If Edwards was convicted under California Penal Code § 415(1), his conviction would
25 qualify as a misdemeanor crime of domestic violence because § 415(1) includes as an element the use
26 or attempted use of physical force. *See* California Penal Code § 415(1). In their Opposition, plaintiffs
27 do not dispute that Edwards was convicted under § 415(1).
28

1 **C. Plaintiffs' Constitutional Claims**

2 1. Standing

3 In their Opposition, plaintiffs contend that they have sustained an injury in fact because they are
4 unable to complete a lawful purchase in light of their inability to truthfully respond to Question 11i
5 (asking whether the applicant has ever been convicted in any court of a misdemeanor crime of domestic
6 violence) and referring to the instructions for exceptions) on ATF Form 4473, a form of which they ask
7 the Court to take judicial notice. Opposition at 19. In support of their contention, plaintiffs cite *Dearth*
8 *v. Holder*, ___ F.3d ___, 2011 WL 1437379 (D.C. Cir. 2011) (holding that plaintiff had standing to
9 challenge 18 U.S.C. §§ 922(a)(9) and (b)(3) and implementing regulations because government “has
10 erected a regulatory scheme that precludes Dearth from truthfully completing the application form the
11 Government requires for the purchase of a firearm.”).

12 Here, however, plaintiffs have not alleged, as the plaintiff did in *Dearth*, that they completed
13 ATF Form 4473 and that their attempts to purchase a firearm failed as a result of their truthful
14 responses to that form. Plaintiffs' First Amended Complaint does not contain any reference to ATF
15 Form 4473. Moreover, while plaintiffs Enos and Edward allege in the First Amended Complaint that
16 they were denied a firearm purchase, they do not specifically allege that the denials were based on their
17 convictions for misdemeanor crimes of domestic violence or their responses to an application to
18 purchase firearms. *See* First Amended Complaint ¶¶ 29i, 33g. Moreover, in a pre-enforcement facial
19 challenge to a criminal statute in the Ninth Circuit, “the plaintiff must show a genuine threat of
20 imminent prosecution under the challenged statute to establish a justiciable case or controversy,”
21 *Washington Mercantile Ass'n v. Williams*, 733 F.2d 687, 688 (9th Cir. 1984), and the fact that the
22 criminal statute is chilling the plaintiffs' desire and ability to purchase firearms is not sufficient. The
23 Ninth Circuit addressed this kind of argument as follows:

24 Another injury that plaintiffs allege is the chilling of their desire and ability to
25 purchase outlawed firearms. Certainly, plaintiffs face a difficult choice whether or
26 not to engage in conduct prohibited under the Act. Nonetheless, their choice is “not
27 unlike that forged by many regulatory statutes with criminal sanctions.” *Boating*
28 *Industry Ass'ns*, 601 F.2d at 1385. As the Fourth Circuit has noted, “[e]very criminal
law, by its very existence, may have some chilling effect on personal behavior. That
was the reason for its passage.” *Doe v. Duling*, 782 F.2d 1202, 1206 (4th Cir. 1986).

San Diego County Gun Rights Committee v. Reno, 98 F.3d 1121, 1129 (9th Cir. 1996).

1 1. Second Amendment

2 In their Opposition, plaintiffs do not set forth any argument in support of their Second
3 Amendment claim or in opposition to the government’s arguments regarding why plaintiffs have failed
4 to state a claim under the Second Amendment. Instead, plaintiffs make the following assertions: (1)
5 the Ninth Circuit has not yet resolved what level of scrutiny is appropriate for gun rights cases; (2) the
6 prohibition on possession of firearms by misdemeanants is not longstanding; (3) they are not
7 challenging 18 U.S.C. § 921(g)(1); and (4) they are only challenging the constitutionality of 18 U.S.C.
8 §§ 921(d)(9) and (g)(9) to the extent these statutes do not provide for the restoration of rights to person
9 convicted of misdemeanors and that “it is the lifetime ban that they challenge, not the underlying policy
10 of suspending the ‘right to keep and bear arms’ of persons suffering convictions of MCDV.”
11 Opposition at 21-22. The government asks the Court to dismiss plaintiffs’ Second Amendment claim
12 with prejudice for the reasons stated in the Motion to Dismiss.

13 2. First Amendment

14 In their Opposition, plaintiffs do not set forth any argument in support of their First
15 Amendment claim or in opposition to the government’s arguments regarding why they have failed to
16 state a claim under the First Amendment. Instead, plaintiffs concede that their First Amendment claim
17 “may be the weakest claim in Plaintiffs’ arsenal” and that the claim was advanced “in the hope of
18 making new law and/or changing existing law.” Opposition at 22. Accordingly, the government asks
19 the Court to dismiss plaintiffs’ First Amendment claim with prejudice for the reasons stated in the
20 Motion to Dismiss.

21 3. Tenth Amendment

22 In their Opposition, plaintiffs do not set forth any argument in support of their Tenth
23 Amendment claim or in opposition to the government’s arguments regarding why they have failed to
24 state a claim under the Tenth Amendment. Instead, plaintiffs state that “[t]his case is about the states
25 retaining the power to decide what crimes to charge (Penal Code § 415 vs. Penal Code § 273.5) and the
26 states’ power to define restoration of rights after a misdemeanor conviction.” Opposition at 22.
27 Accordingly, the government asks the Court to dismiss plaintiffs’ Tenth Amendment claim with
28 prejudice for the reasons stated in the Motion to Dismiss.

1 4. Fifth Amendment

2 In their Opposition, plaintiffs state the following with regard to their Fifth Amendment claim:

3 This is primarily a equal protection claim based on the incongruity of a federal statutory
4 scheme (Remember, this is Defendants’ theory of the case, not ours) in which persons
5 convicted of misdemeanors cannot have their rights restored because they lost no rights,
6 but felons can have their rights restored in Congress ever funds that program. See
7 generally: *U.S. v. Bean*, 537 U.S. 71 (2002). That’s not even rational.

8 Opposition at 22.

9 Plaintiffs do not dispute the government’s contention that a review of the statute plaintiffs are
10 referring to – 18 U.S.C. § 925(c) – reveals that the relief available from the Attorney General under
11 section 925(c) is not limited to applicants who have been convicted of felonies and that it applies to
12 applicants who have been convicted of misdemeanor crimes of domestic violence as well. *See Palma*
13 *v. United States*, 228 F.3d 323, 327-28 (3d Cir. 2000) (stating that persons convicted of a misdemeanor
14 crime of domestic violence may apply for relief under 18 U.S.C. § 925(c)).

15 Plaintiffs also do not dispute the government’s contention that the Seventh Circuit rejected an
16 argument similar to the one made here – that “Congress overreached by creating a ‘perpetual’
17 disqualification for persons convicted of domestic violence.” *United States v. Skoien*, 614 F.3d 638,
18 644 (7th Cir. 2010) (en banc). The Seventh Circuit noted that 18 U.S.C. § 921(a)(33)(B)(ii) provides
19 routes to restoration of the right to possess firearms and that:

20 Some of the largest states make expungement available as of right to misdemeanants
21 who have a clean record for a specified time. California, for example, has such a
22 program. Cal. Penal Code § 1203.4a. This means that § 922(g)(9) in its normal
23 application does not create a perpetual and unjustified disqualification for a person who
24 no longer is apt to attack other members of the household.

25 *Skoien*, 614 F.3d at 645 (internal citation omitted).

26 In light of the fact that plaintiffs have not set forth an argument in support of their Fifth
27 Amendment claim or in opposition to the government’s arguments regarding why they have failed to
28 state a claim under the Fifth Amendment, the government asks the Court to dismiss plaintiffs’ Fifth
29 Amendment claim with prejudice for the reasons stated in the Motion to Dismiss.

30 **D. Improper Joinder**

31 Plaintiffs have failed to satisfy the first prong in Rule 20(a)’s test for permissive joinder. “The
32 first prong, the ‘same transaction’ requirement, refers to similarity in the factual background of a

1 claim.” *Coughlin v. Rogers*, 130 F.3d 1348, 1350 (9th Cir. 1997). In this case, the factual background
2 of each plaintiff is not the same. First, plaintiffs were convicted of different crimes: Enos, Bastasini,
3 Mercado, Groves, and Monteiro were convicted of Willful Infliction of Corporal Injury under
4 California Penal Code § 273.5(a); Erikson and Newman allege they were convicted of misdemeanor
5 crimes of domestic violence, but do not specify which ones; Loughran was convicted of battery under
6 California Penal Code § 242; and Edwards was convicted of Disturbing the Peace under California
7 Penal Code § 415. Second, while Enos, Bastasini, Mercado, Groves, Monteiro, Erikson, and Newman
8 concede they were convicted of misdemeanor crimes of domestic violence, but that their civil rights
9 were restored, Edwards alleges that the crime of which he was convicted, California Penal Code § 415,
10 is not a misdemeanor crime of domestic violence. Third, only Enos and Edwards allege that they
11 actually attempted to purchase a firearm and that were denied. First Amended Complaint ¶ 29i.

12 III. CONCLUSION

13 For the foregoing reasons, the defendants respectfully ask the Court to dismiss the action with
14 prejudice for lack of subject matter jurisdiction under Fed. R. Civ. P. 12(b)(1) and for failure to state a
15 claim under Fed. R. Civ. P. 12(b)(6).
