1 WHEREAS, Plaintiff Therese M. Pizzo has sued in their personal capacities former San
2 Francisco Mayor Gavin Newsom, former San Francisco Chief of Police Heather Fong, and former San
3 Francisco Sheriff Michael Hennessey;

4 WHEREAS, Plaintiff no longer desires to sue Newsom, Fong, and Hennessey in their
5 individual capacities but desires to continue to maintain this lawsuit against the San Francisco Mayor,
6 San Francisco Sheriff, and San Francisco Chief of Police in their official capacities; and

7 WHEREAS, all other parties to this case consent to the dismissal without prejudice of
8 Newsom, Fong, and Hennessey as individuals from this lawsuit.

9 The parties to this Stipulation therefore stipulate and agree as follows:

10 Plaintiff dismisses her individual-capacity claims against former San Francisco Mayor Gavin
11 Newsom, former San Francisco Chief of Police Heather Fong, and former San Francisco Sheriff
12 Michael Hennessey without prejudice. Each party shall bear its own fees and costs in connection with
13 this dismissal.
