20 TO THIS HONORABLE COURT:

21 Pursuant to Northern District Local Rule 6-1, plaintiffs and defendants KAMALA
 22 HARRIS, Attorney General of California and CALIFORNIA DEPARTMENT OF JUSTICE, by
 23 and through their respective counsel, hereby agree and stipulate as follows:

24 1. Plaintiffs recently filed their Amended Consolidated Complaint on September 4, 2012,
 25 after this Court issued its order granting in part, and denying in part, the City of Rohnert Park's
 26 Motion to Dismiss.

27 2. In light of plaintiffs' and the City of Rohnert Park's current settlement negotiations,
 28 plaintiffs and defendants agree to extend defendants' last day to respond to plaintiffs' Amended

1 Complaint.

2 3. Accordingly, defendants KAMALA HARRIS, Attorney General of California and
3 CALIFORNIA DEPARTMENT OF JUSTICE shall have until October 16, 2012 to respond to
4 plaintiffs' Amended Consolidated Complaint.

5 4. The parties are currently scheduled to appear for a Case Management Conference on
6 November 2, 2012. No trial date has been set. This extension does not interfere with any
7 previously scheduled deadline set by this Court.
