**MOTION TO ADMIT JONATHAN K. BAUM AS VISITING ATTORNEY**

Pursuant to L.Civ.R. 83.1(d), *amici curiae* Law Center to Prevent Gun Violence, Connecticut Against Gun Violence, Moms Demand Action for Gun Sense in America, and Cleveland School Remembers (collectively, “Amici”), hereby move the Court to grant Jonathan K. 8. I do not request the modification of any scheduling order or deadlines based upon my application for admission as a visiting lawyer in this case.


9. Amici have requested that I appear as counsel for them in this matter.
