The parties shall be prepared to discuss:

- (a) Service of process on parties not yet served;
- (b) Jurisdiction and venue;
- (c) Track assignment;
- (d) Anticipated motions;

- 1 (e) Anticipated or remaining discovery, including (1) limitation on discovery, (2)
- 2 provisions for disclosure or discovery of electronically stored information, and, (3)
- 3 any agreements the parties reach for asserting claims of privilege or of protection as
- 4 trial-preparation material after production;
- 5 (f) Further proceedings, including setting dates for discovery cut-off, pretrial and trial;
- 6 (g) Appropriateness of special procedure such as consolidation of actions for discovery
- 7 or pretrial, reference to a master or to arbitration, or to the Judicial Panel on Multi-
- 8 district Litigation, or application of the Manual for Complex Litigation;
- 9 (h) Modifications of the standard pretrial procedures specified by this Plan on account of
- 10 the relative simplicity or complexity of the action or proceedings;
- 11 (i) Settlement prospects;
- 12 (j) Any other matter which may be conducive to the just, efficient, and economical
- 13 determination of the proceedings, including the definition or limitation of issues; and,
- 14 (k) Setting of dates for:
 - 15 1. Joinder of all parties,
 - 16 2. Motions to amend,
 - 17 3. Discovery cut-off,
 - 18 4. Status Conferences,
 - 19 5. Discovery motion hearing date,
 - 20 6. Dispositive motion cut-off,
 - 21 7. Dispositive motion hearing date,
 - 22 8. Settlement conference,
 - 23 9. Joint pretrial order,
 - 24 10. Final pretrial order, and
 - 11. Trial.
