

# HOW TO UNDERSTAND YOUR CRIMINAL HISTORY RECORD

### What is a Criminal History Record?

A criminal history record (also known as a "rap sheet") is a record of a person's arrest and conviction history in California. Criminal history records are maintained by the California Department of Justice, Division of Criminal Justice Services (DOJ). Every time a person is arrested and fingerprinted, his or her record is updated to reflect the arrest and the crime charged. The disposition (or outcome) of the arrest also appears on these records.

The DOJ only keeps track of arrests in California, so any federal arrests and arrests from other states will not appear on your California criminal history records. To obtain these criminal history records, you would have to request them from the Federal Bureau of Investigation (FBI), as they maintain a list of federal arrests and arrests from all 50 states. Your criminal history records from the DOJ will cite to your FBI computer code number.

## How to Read Your Rap Sheet

In order to complete the Restoration of Rights Questionnaire for Criminal Convictions, you must obtain a copy review your criminal history record. We have provided 2 samples of criminal history records and steps of how to

- 1. The left column contains the date of your arrest.
- 2. The second column lists the arresting agency.
- 3. Your name appears in the third column.
- 4. The fourth column contains the charge(s) on which you were arraigned. The charges will be summarized by a phrase (e.g., "NARC CONT SUB FOR SALE," which means "narcotic controlled substance for sale" ). This column also lists the corresponding citation in the California Penal Code (e.g., PC 220.21) and sometimes the category of the offense (felony, misdemeanor, or violation). The fourth column also contains the number of charges and the notation "ATTEMPTED" if you did not complete the offense.
- 5. The fifth column on the right reflects the outcome or disposition of the charge (e.g., guilty plea entered, convicted after a trial, or acquitted). If you were convicted, the disposition column should report the type of sentence or fine you received. If you were issued a Certificate of Rehabilitation, that would be

indicated here. Also, the fifth column contains the date your case was heard, the name of the court, and the index or docket number under which your case is filed.

However, keep in mind that your criminal history records may differ from this setup depending on how old they are. Nonetheless, your criminal history records will contain the necessary information that you will need to fill out our questionnaire.

## Key to Sample Criminal History Records # 2

- 1. Header information used for tracking purposes, followed by the database identifier
- 2. "DOE" is an example of the requestor's name. "87000012" is an example of the California Information and Identification Number (CII)<sup>12</sup> of the rap sheet's subject. "CA0180263" is an example of a National Crime Information Center Originating Agency Identifier (ORI). "PBY" is an example of the CII number inquiry transaction.
- 3. Requestor and reason for requesting code. The operator's initials will also be included in this field if the operator is different than the requestor.
- 4. "Live scan" indicates that live scan fingerprint record is on file. CII Number and physical descriptors of rap sheet subject. Also includes all names and monikers used by the subject. The first name listed (01) is the name used when the record was established (first fingerprint card/live scan submission).
- 5. Identifying numbers issued to and used by subject. Identifying descriptors of subject.
- 6. "ARR/DET/CIT"=Arrest/Detention/Citation. The second line shows the date of the ARR/DET/CIT, the agency type making the ARR/DET/CIT (e.g., California Police Department), and the location of the ARR/DET/CIT.
- "CNT" = Count (CNT:01 means the first charge). The first count includes the agency-issued record identifier (agency case number, booking number, etc.). Also, charges are indicated by the cod section violated (e.g., Penal Code § 537E(A)).
- 8. "COM" = Comments. The comments indicate multiple counts in the same section.
- 9. Dashed lines meant he end of one section and the start of the next section,
- 10. Indicates a section re: court action. Has information on date and location of the court.
- 11. Counts listed in the court action (not always the same as the ARR/DET/CIT section). The first count is followed by the court case number, and each charge is followed by the disposition (DISPO).
- 12. "DISPO" = Disposition, or outcome, of the case. Convictions will often include the level (felony, misdemeanor). Convictions resulting from a plea will show the sentence while convictions resulting from a court or jury trial will not.
- 13. This is when the court has ordered a custody sentence. The Custody Type will follow the word "Custody" (e.g., CYA, County, CDC). The date that you are accepted by the custody facility will be followed by the custody facility information (e.g., CA=California, YA=Youth Authority) and location.

- 14. The Institution Number (INN) follows the first count on the first line. The charge appears on the second line, and the third line here is for the court case number.
- 15. This shows the date of custody release, followed by the disposition (e.g., CYA parole) and the responsible agency (e.g., California Parole=CAPA).
- 16. The discharge date will be followed by a DISPO of "DISCHARGED" if the release from custody is to parole/probation and if you successfully complete parole/probation.
- 17. This is added to the end of all felony convictions.
- 18. Indicates the end of a "print event," which means that information beyond this point is the result of additional fingerprint submissions.
- 19. "SUPPLEMENTAL ARR" = additional charges added after the initial arrest is made.
- 20. An arrest for warrants that is a complete cycle with no court action indicated
- 21. Custody information related to the above arrest only cycle.

## What to Look for in Your Criminal History Records

For one, it is important that you check your criminal history records for mistakes. Some common mistakes are:

- **Incorrect entries**: Check to make sure that all of the information is correct, as far as you can remember. For example, your criminal history records could contain a typo, reporting that you were convicted of California Penal Code section 461 (Burglary) when you were actually convicted of California Penal Code section 416 (Assembly for the Purpose of Disturbing the Peace).
- **Incomplete entries**: Check to make sure that each arrest entry on your criminal history records contains the most complete information as to the final outcome of the arrest. Because law enforcement and courts may forget to inform the DOJ about the outcome of cases, criminal history records often report arrests without stating the final disposition (i.e., they state "no disposition reported"). You do not want this to happen to your criminal history records because people who see your criminal history records might then assume the worst. For example, they might assume that the original arrest charge is outstanding and that there is a warrant for your arrest or that you were found guilty of the original arrest charge when you were actually acquitted or convicted of less serious charges.

Second, review your criminal history records to spot cases that can be sealed, expunged, or purged but are currently not. For more information on the expungement, sealing, and purging of cases and other remedies, please = read Chapter 3 of our book, *California Gun Laws: A Guide to State and Federal Firearm Regulations*. ## **Clarification of Selective Terms Found in Your Criminal History Records**

- Infraction: A noncriminal case with a penalty of a fine rather than imprisonment.
- **Misdemeanor**: A misdemeanor is a crime punishable by maximum confinement of one year in jail. Misdemeanors also carry fines, commonly a maximum fine of \$1,000.00.
- **Felony**: A felony is a crime punishable by minimum confinement of one year in state prison. Felonies are commonly also punished by fines and formal, supervised probation.
- **"Wobbler"**: Crime that can be charged as either a misdemeanor or a felony depending on the circumstances. Notably, a skillful attorney can many times reduce a wobbler charged as a felony to a misdemeanor.
- **Deferred Entry of Judgment**: The court defers judgment and sentence, and your guilty plea will not be listed as a conviction if you plead guilty and complete probation or treatment.
- **Pre-plea Drug Diversion**: The court will ultimately dismiss your charges if you successfully complete a program involving counseling, drug testing, education, and other conditions. The court also has discretion to reinstate your criminal charges if it finds your conduct or progress during the program to be unsatisfactory.
- **Bench Warrant**: A bench warrant is issued for your arrest if you fail to appear on your assigned court date.
- **Conditional Sentence**: The court will discharge you and not require you to serve time in jail if you satisfy certain conditions, such as attending an alcohol or drug treatment program. However, your guilty plea or verdict is still considered a conviction.
- Vacating or Setting Aside a Guilty Plea or Verdict: If a court vacates or sets aside your guilty plea or verdict, you can then apply for a Certificate of Rehabilitation, pardon, and expungement. However, your guilty plea or verdict is still considered a conviction.
- **Expungement** (a.k.a. having a case "set aside and dismissed"): A remedy indicated by "DISM, FURTH OF JUST" or "dismissed pursuant to PC 1203.4" in your criminal history records, informing the reader that your conviction has been dismissed in furtherance of justice. Most adult misdemeanor and felony convictions and most criminal juvenile convictions can be expunged.
