On June 9, 2016, this Court issued its en banc opinion in this appeal, and the companion appeal, *Richards et al. v. Prieto et al.*, No. 11-16255. Plaintiffs-Appellants moved the Court for a full court rehearing en banc. (*Peruta*, No. 10-56971, Dkt. No. 334; *Richards*, No. 11-16255. Dkt. No. 335.) On June 24, 2016, this Court ordered Intervenor State of California to file a response to the petitions by July 15, 2016. (Dkt. No. 336.)

The undersigned counsel, currently employed by the State of California, was previously employed by this Court as a staff attorney from 2007 to 2012. Counsel moves under Ninth Circuit Rule 46-5 for an exemption to allow her to participate in further action in this case. Counsel has filed concurrently a "Notice of Appearance of Counsel" in order to file this application.

ARGUMENT

Under Rule 46-5, a former employee of this Court is barred from participating or assisting "by way of representation, consultation, or otherwise, in any case that was pending in the Court during the employee's period of employment." 9th Cir. R. 46-5. A former employee may apply for an exemption from this restriction if the attorney had no direct or indirect involvement with the case and was not employed or assigned in the chambers of any judge who participated in the case during the attorney's employment with the Court. *Id*.

The undersigned counsel worked as a staff attorney for this Court from March 19, 2007 until May 28, 2012. Boergers Decl. ¶ 2. During this time, to her knowledge, counsel had no direct or indirect involvement with this appeal, No. 10-56971, or the companion appeal, No. 11-16255. *Id.* ¶ 4. Further, the undersigned counsel was neither employed by nor assigned to the chambers of any judge. *Id.* ¶ 3. Accordingly, counsel fits the parameters for an exemption.

CONCLUSION

The undersigned counsel respectfully requests that the Court grant an exemption from Ninth Circuit Rule 46-5 and allow her to represent the State of California in this appeal.
