Pursuant to Rule 16(b) of the Federal Rules of Civil Procedure, the parties attended a Case Management Conference on November 17, 2011. After considering the Joint Case Management Statement submitted by the parties and consulting with the attorneys of record for the parties and good cause appearing, IT IS HEREBY ORDERED THAT:

1. DISCOVERY.

On or before August 15, 2012, all non-expert discovery shall be completed by the parties. Discovery shall be limited as follows: (a) ten (10) non-expert depositions per party; (b) twenty-five (25) interrogatories per party, including all discrete subparts; (c) a reasonable number of requests for production of documents or for inspection per party; and (d) a reasonable number of requests for admission per party.

1           2.       EXPERT WITNESSES. The disclosure and discovery of expert witness opinions  
2 shall proceed as follows:

3           A. On or before September 1, 2012, plaintiff shall disclose expert testimony and reports in  
4 accordance with Federal Rule of Civil Procedure 26(a)(2).

5           B. On or before September 15, 2012, defendant shall disclose expert testimony and reports  
6 in accordance with Federal Rule of Civil Procedure 26(a)(2).

7           C. On or before October 1, 2012, all discovery of expert witnesses pursuant to Federal Rule  
8 of Civil Procedure 26(b)(4) shall be completed.

9           5.       FURTHER CASE MANAGEMENT CONFERENCE. A Further Case Management  
10 Conference shall be held on **August 23, 2012 at 10:00 a.m.** in Courtroom 3, 17th Floor, United  
11 States Courthouse, 450 Golden Gate Avenue, San Francisco, California. The parties shall file a  
12 Joint Case Management Statement at least one week prior to the Conference.

13           6.       PRETRIAL MOTIONS. All pretrial motions must be filed and served pursuant to  
14 Civil Local Rule 7. All pretrial motions shall be heard no later than December 13, 2012.

15           7.       PRETRIAL STATEMENTS. At a time convenient to both, counsel shall meet and  
16 confer to discuss preparation of a joint pretrial statement, and on or before January 31, 2013,  
17 counsel shall file a Joint Pretrial Statement.

18           8.       PRETRIAL CONFERENCE. The final pretrial conference will be held on **February**  
19 **14, 2013, at 10:00 a.m.**, in Courtroom 3, 17th Floor, United States Courthouse, 450 Golden Gate  
20 Avenue, San Francisco, California. Each party or lead counsel who will try the case shall attend  
21 personally.

22           9.       TRIAL DATE. Trial shall commence on **February 25, 2013, at 9:00 a.m.**, in  
23 Courtroom 3, 17th Floor, United States Courthouse, 450 Golden Gate Avenue, San Francisco,  
24 California.
