**MEMORANDUM OF PLAINTIFF NATIONAL RIFLE ASSOCIATION  
PURSUANT TO ORDER AWARDING ATTORNEY'S FEES**

Pursuant to this Court's Memorandum Opinion and Order ("Order 1"), dated June 25, 2012, awarding attorney's fees to Plaintiff National Rifle Association ("NRA") against the Village of Oak Park and the City of Chicago, Plaintiff hereby submits its recalculation of its total fees in conformity with the said opinion. Plaintiff also addresses the issue raised in the Court's supplemental Memorandum and Order dated June 28, 2012 ("Order 2").

As provided by Order 1, "this Court awards NRA the fees it demands," except that Halbrook's hourly rate is set at \$450, and he may not claim fees for August 15, 2009 through June 28, 2010; Kolodziej's hourly rate is set at \$300 per hour, and Brenner may not claim fees for work performed during the time the cases were consolidated.<sup>1</sup> Order 1 at 20-21. The Court ordered NRA to submit its recalculation of its total fees and to include copies of Halbrook's and Brenner's billing statements with the stricken time entries crossed-out or otherwise noted. *Id.* at 21. Those billing statements are attached herewith as Halbrook's Exhibit B (Revised) and Kolodziej's Exhibit A (Revised).

The Court's decision was based on the information submitted in the joint statement of the parties and exhibits originally filed with NRA's motions for attorney's fees pursuant to Local Rule 54.3(e) & (f). NRA is entitled to a further fee award for litigating the fee motions and, should it be unable to settle the amount with Defendants, reserves the right to file supplemental motions for attorney's fees. See *Robinson v. City of Harvey, Ill.*, 617 F.3d 915, 917 (7<sup>th</sup> Cir. 2010) ("Supplemental awards of legal fees are common.").

On the matter addressed in the Court's supplemental Memorandum and Order dated June 28, 2012, the Court noted NRA's statement that Chicago and Oak Park are jointly and severally

liable for a portion of the fee award, but stated: “Instead the more fair approach will be to allocate the largest part of the fee award -- the portion that NRA ascribes to both lawsuits -- ratably between Oak Park and Chicago, so that each will bear (1) a several (and not joint) liability for that ratable share plus (2) the amount that NRA has ascribed to that defendant alone.” Order 2 at 2.

The reason NRA believes the defendants should be jointly and severally liable is that it would have taken exactly the same amount of work to litigate a single case against just one of these defendants as it took to litigate the case against both. If one defendant for whatever reason does not or cannot pay the fees, the other defendant should do so. While these were two separate lawsuits that were consolidated, they involved the same constitutional issue, and from the beginning Chicago and Oak Park litigated these cases as a team in unison. “Ordinarily tortfeasors are jointly and severally liable, with the plaintiff having the free choice of whom to pursue (subject to possible contribution among the tortfeasors at the behest of the defendant required to pay in the first instance).” *Strama v. Peterson*, 561 F. Supp. 997, 1000 (N.D. Ill.1983).

“When two or more defendants actively participate in a constitutional violation, they can be held jointly and severally responsible for indivisible attorneys' fees.” *Molnar v. Booth*, 229 F.3d 593, 605 (7th Cir. 2000), citing *Herbst v. Ryan*, 90 F.3d 1300, 1305 (7th Cir. 1996). Here, the constitutional violation by both defendants was identical, and they agreed to defend it jointly. Accordingly, they should be held jointly and severally liable.

### **CONCLUSION**

The Court should award Plaintiff NRA attorney's fees (1) against Chicago and Oak Park jointly and severally in the amount of \$961,460.71, (2) against Chicago in the amount of

\$39,074.50, and (3) against Oak Park in the amount of \$326,052.98. In addition, NRA should be granted leave to file a supplemental motion for attorney's fees in each case related to the litigation of the motions for attorney's fees.

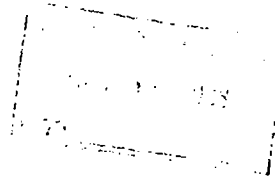
