2	I, Janie Ito, declare as follows:	
3	1. I am the Chief of the Public Services Division of the Los Angeles County Coroner	
4	where I have been employed in this position since 1995 and have been within the Public Services	
5	Division for more than 10 years. Part of my duties include supervising the preparation and	
6	maintenance of records kept by the Coroner's Department. Except as otherwise stated, I have	
7	personal knowledge of the facts stated below and if called to testify, could and would testify to them	
8	competently.	
9	2. I requested that an employee from our Forensic Data Information Systems Division	
10	perform a computer search to determine how many firearm suicides and accidental firearm shootings	
11	resulting in death there were from 1996 to 2000. In Los Angeles County, from the period 1996 to	
12	2000, there were approximately 1,908 suicides by firearm, and 50 accidental firearm shootings	
13	resulting in death.	
14	3. As the Chief of Public Services, I am familiar with the time required to pull cases	
15	within the Coroner's Department. On average, it takes 7 hours per 100 cases to pull the file and	
16	retrieve the information. Cases from 1996 through 1998 are located in boxes in our Archive Section	
17	and take longer to retrieve. Based on a 40 hour workweek, it would take approximately 3.5 weeks to	
18	pull the backup documentation for both suicide and accidental deaths by firearm. This effort would	
19	be extremely burdensome for my department, particularly when the database is available and can be	
20	obtained with relatively little impact on the resources of the Coroner's Department.	
21	I declare under penalty of perjury under the laws of the State of California that the foregoing
