I, MERVAT FARAG, declare as follows:

- 1. I am an EDP Programmer Analyst of the Forensic Data Information Systems Division of the Los Angeles County Coroner where I have been employed in this position since 1989. Part of my duties include maintaining the data and information systems kept by the Coroner's Department. Except as otherwise stated, I have personal knowledge of the facts stated below and if called to testify, could and would testify to them competently.
- 2. Employees of the Forensic Data Information Systems Division can search electronically through a Los Angeles County Coroner database to determine the quantity of firearm suicides or deaths by accidental firearm shootings. The electronic database can also sufficiently identify the sex, age, place of death, and place of injury as well as eliminate confidential information relating to next of kin. Compilation of this database containing relevant information would be relatively easy to gather and would take approximately one week.
- 3. Iperformed a computer search to determine how many firearm suicides and accidental firearm shootings resulting in death there were from 1996 to 2000. In Los Angeles County, from the period 1996 to 2000, there were approximately 1,908 suicides by firearm, and 50 accidental firearm shootings resulting in death.
