PLAINTIFF'S UNOPPOSED MOTION TO STRIKE PAGE FROM THE DOCKET AND FOR LEAVE TO RE-FILE REDACTED COMPLAINT

Plaintiff Shawn Gowder, by and through his attorney, Stephen A. Kolodziej of the law firm of Brenner, Ford, Monroe & Scott, Ltd., respectfully moves the court to strike the last page of Exhibit A to plaintiff's complaint from the court's docket, and to grant plaintiff leave to re-file his complaint with said page redacted. In support of this motion, plaintiff states as follows:

1. Plaintiff filed this action in the Circuit Court of Cook County, Illinois, from which it was removed by defendants City of Chicago Department of Police and Jody P. Weis to this court. A copy of plaintiff's complaint was attached to these defendants' notice of removal and appears on the court's docket at Document #1, pp.13-61.

2. The undersigned counsel for plaintiff has discovered that the last page of Exhibit A to plaintiff's complaint, which appears at Document #1, p. 47, is an internal e-mail of counsel's

office unrelated to this case, which was inadvertently included with the Chicago Municipal Code Chapter 8-20, which comprises Exhibit A. This page is not part of Chapter 8-20, has no relationship to this case, and should not have been included as part of Exhibit A. It should therefore be stricken from the court's docket.

3. The undersigned counsel for plaintiff has discussed this inadvertent inclusion with defendants' counsel, Rebecca Hirsch, who agreed that page 47 of Document #1 should be stricken from the court's docket, and has no objection to the court so ordering.

4. Plaintiff further requests leave to re-file his complaint, bearing this court's caption, with the last page of Exhibit A redacted. No textual changes will be made to the complaint itself, other than to substitute this court's caption for the original caption of the Circuit Court of Cook County, Illinois.

WHEREFORE, plaintiff respectfully prays that the court enter an order striking page 47 of Document #1 from Exhibit A to plaintiff's complaint, and from the court's docket. Plaintiff further requests leave to re-file his complaint, bearing this court's caption, with said page redacted from Exhibit A.
