Dear Mr. Harris:

I write to request an extension of time for respondents the City & County of San Francisco and its officials to respond to the petition for certiorari filed in this case. San Francisco's brief in opposition to certiorari is presently due on January 15, 2015. I request an extension of time through and including Friday, February 13, 2015 to file this brief.

The reason for this request is the press of other business. I am drafting a brief due to the Ninth Circuit Court of Appeals on January 14, 2015 in *Bui v. City & County of San Francisco*, No. 14-16585, and a brief due to the San Francisco Superior Court on January 14, 2015 in *State Lands Commission v. City & County of San Francisco*, No. CGC-14-540531. In addition, I am assisting with representation of San Francisco in *City & County of San Francisco v. Sheehan*, No. 13-1412 in this Court, and petitioners' opening merits brief in that case is due on January 9, 2015. Finally, I am traveling with my family for the holidays and will be out of the office from December 24, 2014 through December 29, 2014, further limiting the time I can devote to responding to the petition.

I have consulted with opposing counsel about this request and have been informed by Clint B. Monfort of Michel & Associates, counsel for petitioners, that petitioners do not object to San Francisco's request for a 30-day extension. Nor will this request for an extension have an adverse impact on the Court's calendar. Under the present schedule, the petition would likely be considered no sooner than at the Court's February 20, 2015 Conference, such that the case could not be calendared for argument in O.T. 2014 regardless of any extension.


