Dear Mr. Harris:

I write to request a further extension of time for respondents the City & County of San Francisco and its officials to respond to the petition for certiorari and the four briefs of *amici curiae* supporting certiorari filed in this case. San Francisco's brief in opposition to certiorari is presently due on February 13, 2015, which reflects a 30-day extension of time that this Court has already granted. I request a further extension through and including Friday, March 13, 2015 to file this brief.

The reason for this request is the press of other business. I am drafting a brief due to the Ninth Circuit Court of Appeals in *Levin v. City and County of San Francisco*, No. 14-17283, on February 26, 2015, and a brief due to the San Francisco Superior Court on January 28, 2015 in *State Lands Commission v. City & County of San Francisco*, No. CGC-14-540531.

I have consulted with opposing counsel about this request and have been informed by Clint B. Monfort of Michel & Associates, counsel for petitioners, that petitioners do not object to San Francisco's request for a further extension. Nor will this request for an extension have an adverse impact on the Court's calendar in my view. Should the Court grant certiorari in this case, the case could not be heard in the current Term in any event, nor will the further extension cause the petition to be considered after the Court's summer recess.


