association, and Defendant CITY OF LOS ANGELES, through their respective counsel of record, that Defendant CITY OF LOS ANGELES shall have up to and including July 27, 2012 in which to file an Answer to the Complaint or a Motion to Dismiss, or to a date thereafter that is convenient to the Court. An Answer to the Complaint or Motion under Rule 12 of the Federal Rules of Civil Procedure was originally due on May 30, 2012.

Good cause for an extension exists in that, since this Honorable Court's denial of Plaintiff's application for a temporary restraining order on May 11, 2012, counsel for Plaintiff and Defendant have been engaged in discussions regarding possible resolution of this matter without the need for further litigation, there have been no prior requests for an extension, and no prejudice would result to either party if the extension is granted.
