Any and all records regarding, concerning, or related to the January 9, 2013 White House meeting attended by Chief Advisor to the Mayor for Policy and Strategic Planning John Feinblatt, Vice President Biden, Attorney General Eric Holder, and others. This request includes, but is not limited to, any and all notes, talking points, briefing books, and internal memoranda produced in preparation for, during, and/or subsequent to the meeting.

The time frame for this request is December 14, 2012 and the present.

For the purposes of this request, the term "record" means any information kept, held, filed, produced or reproduced by, with or for an agency or the state legislature, in any physical

form whatsoever including, but not limited to, reports, statements, examinations, memoranda, opinions, folders, files, books, manuals, pamphlets, forms, papers, designs, drawings, maps, photos, letters, microfilms, computer tapes or discs, rules, regulations or codes. Public Officers Law, § 86(4).

Within five (5) days of receipt of this request, you are required to grant or deny access to the requested documents in whole or in part, or if more time is needed, to acknowledge the receipt of the request in writing. Public Officers Law, § 89(3). If additional time is required to fulfill the request, the acknowledgement must include a reasonable approximate date within twenty business days indicating when it can be anticipated that the request will be granted or denied. Public Officers Law, § 89(3). Failure to respond within the allotted time will be considered a denial of the request. Public Officers Law, §89(4)(a).

Except with respect to records exempt from disclosure by express provision of law, you are also required to make the requested records promptly available up on payment of any fees covering direct costs of duplication or any applicable statutory fees. Any reasonably segregable portion of a record otherwise exempt from disclosure is required to be made available after deletion of the portions that are exempted by law. Public Officers Law, § 87(2). If any portion of this request is withheld or denied, please inform me of the reasons for the denial in writing and provide the name and address of the person or body to whom an appeal should be directed
