**EXPERIENCE IN FIREARMS**

3. I currently own several firearms which I maintain for self-defense and target shooting.

4. I first began using firearms at the age of 9. I have continued in that activity for over 40 years. I have received formal training in firearms use and hold concealed carry permits from the states of Oregon and Nevada. I currently engage in target shooting at least once a month.

**BALLOT MEASURE C**

5. I was one of the residents in Sunnyvale who opposed Ballot Measure C. I composed the ballot arguments against Measure C and maintained a website – Sunnyvale Citizens for a Better Community – containing arguments against Measure C. One of the objectionable provisions in Measure C is section 9.44.060 making it unlawful for anyone to sell ammunition in the City of Sunnyvale without obtaining the following personal information from the purchaser: name, address, date of birth, driver's license number, brand, type and quantity of ammunition purchased, signature, and thumbprint.

6. I object to providing such information when purchasing ammunition because it invades my right of privacy.

**AMMUNITION PURCHASES**

7. Over the last several years, I have purchased ammunition from: U.S. Firearms Co. and the Big 5 Sporting Goods store in Sunnyvale, California, Internet sellers, and out-of-state sellers in Reno, Nevada.

8. My last purchase of ammunition from U.S. Firearms occurred during the summer of 2013. I regularly purchase several types of firearms ammunition, and others, less frequently.

9. During my entire experience in California, I have never been required to provide personal information to any seller of ammunition.

10. After the passage of Measure C, I am unwilling to purchase ammunition from U.S. Firearms, the Big 5 Sporting Goods store, or any other Sunnyvale ammunition seller because of the requirement to disclose personal, confidential information.

**ALTERNATIVE SOURCES OF AMMUNITION**


11. Within about five miles from my house, there are four other ammunition stores located in cities that do not require that personal information and fingerprints be obtained from ammunition purchasers. They are:

- (a) Kerley's Hunting & Outfitting, 20301 Stevens Creek Boulevard, Cupertino, California 95014;
- (b) Eddy's Shooting Sports, 400 Moffett Boulevard, Mountain View, California 94043;
- (c) Bay Area Gun Vault, 363 West El Camino Real, Mountain View, California 94040; and
- (d) Reed's Indoor Range, 1100 Duane Avenue, Santa Clara, California 95054.

12. I am a law-abiding citizen and not prohibited from purchasing firearms.

I declare under penalty of perjury, under the laws of California, that the foregoing is true and correct.
