DECL. OF ALVIN DOE ISO MOTION FOR PRELIMINARY INJUNCTION

I, Alvin Doe, declare:

- 1. I am a Plaintiff in this matter. I have personal knowledge of the matters set forth in this declaration, and would be able to testify competently to these facts if called as a witness. I am using a fictitious name because I fear criminal prosecution and retaliation based on the activities described in the complaint and detailed below.
- 2. I hold a federal firearms license as a collector of curios and relics, issued pursuant to Chapter 44 (commencing with Section 921) of Title 18 of the United States Code. I also have a current certificate of eligibility issued by the California Department of Justice ("DOJ"). True and correct copies of my current federal firearms license and certificate of eligibility are attached to this declaration as Exhibits 1 and 2. My personal information has been redacted to protect my privacy.
- 3. More than once in the past, I have applied to purchase multiple non-curio or relic handguns within a thirty-day period based on the statutory exemption in Penal Code section 27535(b)(9), and those applications were approved.
- 4. I am aware of the DOJ's new enforcement policy that interprets the licensed collectors' exemption in Penal Code section 27535(b)(9) to apply only to applications to purchase curios or relics.
- 5. On April 24, 2014, I applied to purchase multiple non-curio or relic handguns from a licensed firearms dealer in Orange County. On or about May 1, 2014, the DOJ cancelled all but one of the applications on the grounds that I was not exempt, as a licensed collector, under section 27535(b)(9) to apply to purchase multiple non-curio or relic handguns in a thirty-day period.
- 6. But for the fear of prosecution or other adverse action by the DOJ or law enforcement agencies, I would submit additional applications to purchase non-curio or relic handguns that would violate the DOJ's enforcement policy.
