22 I, Susan K. Smith, declare as follows:


23 1. I am an attorney admitted to practice before the Courts of the State of California. I

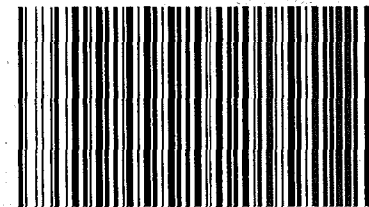

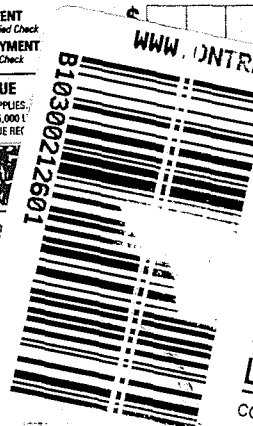
