The video showing Plaintiff's arrest cannot be converted to PDF format, and therefore cannot be submitted electronically through the Court's CM/ECF system.

Defendants seek to submit the certified video of Taylor's incident and the dispatch

call log conventionally through the submission of a DVD-ROM and CD.
