DECLARATION OF DOMINIC NARDONE

I. I, Dominic Nardone, am a plaintiff in the above-entitled action. I make this
 declaration of my own personal knowledge and, if called as a witness, I could and
 would testify competently to the truth of the matters set forth herein.

5 2. I am over the age of 21 and a current resident of Los Angeles County,
6 California.

7 3. I satisfy all applicable requirements to possess a firearm under state and
8 federal law and currently own a handgun.

9 4. I am not prohibited from owning firearms under the laws of the United
10 States or the state of California. I have never been found by any law enforcement
11 agency, any court, or any other government agency to be irresponsible, unsafe, or
12 negligent with firearms in any manner.

13 5. I am a Vietnam veteran and have served in the U.S. Navy as a diver and a14 shooting instructor in small arms.

I applied with Los Angeles County Sheriff James McDonnel for a Carry
License on March 28, 2014, using the California Department of Justice's standard
application form that the Sheriff's Department provided me. I asserted as my "good
cause," a desire to defend myself and my family.

19 7. On May 14, 2015, Sheriff McDonnel denied my application for lack of
20 "good cause" because, according to him, I did not face a significant enough threat to
21 warrant a Carry License. A true and correct copy of the denial letter is attached hereto
22 as Exhibit 2.

8. I repeatedly requested reconsideration of Sheriff McDonnel's denial, but to
no avail.

9. I do not currently qualify for any of the exceptions to California's carry
restrictions that would allow me to carry a firearm outside my home for self-defense
in some manner.

28 10. I fear that if I am attacked, I will not be able to protect myself, because I

cannot lawfully carry a firearm outside my home in any manner.

I wish to immediately exercise my constitutional right to carry a firearm in 11. public for self-defense, but I am precluded from doing so because I am unable to obtain a license to carry a firearm and California generally prohibits me from carrying a firearm in any manner, openly or concealed, without such a license.

12. But for California's comprehensive restrictions on the public carriage of firearms and my inability to obtain a Carry License, I would lawfully carry a firearm in non-sensitive public places for self-defense, but I refrain from doing so for fear of liabilities for violating one or more of California's laws that criminalize my doing so.

13. I am thus completely barred from exercising my right to bear arms for selfdefense without risking criminal prosecution.

I declare under penalty of perjury that the foregoing is true and correct. Executed within the United States on September 11, 2017.

Thank you for writing me about your concealed weapon license (CCW). We have reviewed all of the documentation attached to your letter.

I sincerely appreciate your commitment to responsible gun ownership, however, your application does not meet the criteria for a CCW from the Los Angeles County Sheriff's Department. As you know, we only issue a license when an applicant can demonstrate an imminent threat that cannot otherwise be handled by existing law enforcement resources. You have yet to establish such a threat.

We are actively monitoring ongoing court cases on the topic of CCWs and we will ensure that our policy remains entirely consistent with State and Federal law.
