Briefly describe the dispute that gave rise to this lawsuit.

Plaintiffs challenged California Penal Code Section 32310, the State's ban on the manufacture, sale, import, transfer, and possession of firearm magazines capable of holding over 10 rounds of ammunition on the grounds that it violates several provisions of the U.S. Constitution.

Plaintiffs are individuals who lawfully own and possess magazines over 10 rounds or would immediately acquire such magazines, but for the enforcement of section 32310, and a self-defense civil rights organization. Plaintiffs contend the law violates their rights under the Second Amendment, the Takings Clause, and the Due Process Clause.

Briefly describe the result below and the main issues on appeal.

The district court granted Plaintiffs' Motion for Preliminary Injunction, finding they were likely to succeed on the merits of their claims that section 32310 violates the Second Amendment, the Takings Clause, and the Due Process Clause of the U.S. Constitution. This Court is asked to determine whether the district court abused its discretion in finding that, on the current record, Plaintiffs were likely to succeed on the merits of their claims and had met the remaining preliminary injunction factors.

Describe any proceedings remaining below or any related proceedings in other tribunals.

This interlocutory appeal deals only with the district court's order granting Plaintiffs' Motion for Preliminary Injunction. The case is currently proceeding on the merits in the court below.

Different plaintiffs filed a separate challenge to section 32310 in the Eastern District of California. That case, Wiese v. Becerra, 2:17-cv-00903-WBS-KJN, is also ongoing.

Because this appeal involves questions regarding the constitutionality of a state law, Plaintiffs believe it is not suitable for mediation.
