DECLARATION OF NIALL STALLARD

1. I, Niall Stallard, a resident of Fresno County, California and a citizen of the United States, am a plaintiff in the above-entitled action. I make this declaration of my own personal knowledge and, if called as a witness, I could and would testify competently to the truth of the matters set forth herein.

2. I am a law-abiding citizen who is not prohibited from firearm ownership under the laws of the United States or the state of California. I have never been found by any law enforcement agency, any court, or any other government agency to be irresponsible, unsafe, or negligent with firearms in any manner.

10 3. I currently own a semi-automatic, centerfire rifle that qualifies as an "assault weapon" 11 under the most recently amended definition in California Penal Code section 30515, subdivision (a)(1). I 12 lawfully obtained this firearm between January 1, 2001, and December 31, 2016, and have continued to 13 possess it since that time for lawful purposes, including self-defense.

4. I intend to register my rifle as an "assault weapon" prior to July 1, 2018, because, if I do not, I can no longer lawfully possess it per California Penal Code section 30900, subdivision (b). I have 16 refrained from registering it at this time because I do not wish to be forced to comply with Defendant's illegally adopted and invalid regulations as a condition of being able to do so. But for Defendant's current regulations being illegal, I would immediately register my rifle as an "assault weapon."

5. I currently own a semi-automatic shotgun that does not have a fixed magazine, making the shotgun an "assault weapon" pursuant to sections 5470-5472 of the California Code of Regulations, which I do not wish to register as an "assault weapon" because I am not required to do so under California law.

23 6. I filed this lawsuit for the purpose of being able to register my rifle, and thus continue to 24 possess, my property ("assault weapon") without being subjected to Defendant's illegally adopted and 25 invalid regulations.
