1 IT IS HEREBY ORDERED that: Judgment is ENTERED in favor of California
2 Attorney General Xavier Becerra, in his official capacity as Attorney General of the
3 State of California, and Sheriff James McDonnell, in his official capacity as Sheriff
4 of Los Angeles County, California (“Defendants”) and against Michelle Flanagan,
5 Samuel Golden, Dominic Nardone, Jacob Perkio, and the California Rifle & Pistol
6 Association, Inc. (collectively, “Plaintiffs”). Plaintiffs shall take nothing from
7 Defendants. Each and every claim and prayer for relief in Plaintiffs’ complaint
8 against each Defendant is denied for the reasons set out in this Court’s February 23,
9 2017 order granting Defendants’ motions to dismiss Plaintiffs’ complaint (Dkt. 39)
10 and the May 7, 2018 order granting Defendant Becerra’s Motion for Summary
