Briefly describe the dispute that gave rise to this lawsuit.

California law bars the open carry of firearms in public, subject to limited exemptions not applicable to plaintiffs. It also generally bars concealed carry without a permit (i.e., CCW). Local sheriffs or chiefs of police approve CCW applications. L.A. County Sheriff James McDonnell maintains a policy requiring applicants show extraordinary need, beyond general self-defense, before a CCW will issue. Each plaintiff seeks either to obtain a CCW to carry concealed for self-defense without establishing a special need to do so or to be able to carry openly for self-defense. California's carry regime, including state laws about concealed and open carry, together with LASD's policy, effectively bars plaintiffs from bearing arms outside the home for self-defense. Plaintiffs thus claim the law violates their rights to keep and bear arms and to equal protection.

Briefly describe the result below and the main issues on appeal.

The district court granted Defendant McDonnell's motion to dismiss all claims and dismissed McDonnell from the suit. The court partially granted Defendant Becerra's motion to dismiss plaintiffs' Second Amendment challenge to California's concealed carry scheme and all equal protection claims. The court later denied plaintiffs' motion for summary judgment, and granted Becerra's, on all remaining claims. On appeal, the issue is whether California's carry regime, including the prohibition on public carry and restrictions on concealed carry, together with Sheriff McDonnell's CCW policy requiring evidence of a specific need, beyond self-defense, violates the Second Amendment and/or the Equal Protection Clause?

Describe any proceedings remaining below or any related proceedings in other tribunals.

There are no proceedings remaining in the court below. Plaintiffs note, however, that they anticipate filing a second notice of appeal in this matter in light of the issuance of an amended judgment by the district court.

Plaintiffs are aware of the following firearm carry cases pending before other tribunals: Gould v. O'Leary (First Circuit); Young v. Hawaii (Ninth Circuit); Nichols v. Brown (Ninth Circuit); NYSRPA v. Beach II (USDC NDNY); Rogers v. Grewal (USDC NJ).

This case involves critical constitutional questions concerning the scope of the Second Amendment, generally, and the right to bear arms in public, more specifically. These are not the sorts of questions likely to be resolved through mediation.
