APPLICATION FOR EXEMPTION TO CIRCUIT RULE 46-5

Pursuant to Ninth Circuit Rule 46-5, a former employee of the Court "may apply to the Court for an exemption" to that rule's bar on former employees participating or assisting "by way of representation, consultation, or otherwise, in any case that was pending in the Court during the employee's period of employment." The application for an exemption "must demonstrate that the attorney had no direct or indirect involvement with the case during employment with the Court, and that the attorney was not employed or assigned in the chambers of any judge who participated in the case during the attorney's employment with the Court." Ninth Circuit Rule 46-5.

Kalikoʻonalani D. Fernandes is a former Ninth Circuit law clerk seeking an exemption to Ninth Circuit Rule 46-5 in order to represent the State of Hawaiʻi in this case. This case was pending during Ms. Fernandes' employment with the Ninth Circuit, but Ms. Fernandes had no direct or indirect involvement with the case during her employment. Moreover, to Ms. Fernandes' knowledge, she was not employed or assigned in the chambers of any judge who participated in the case during her employment with the Court. *See* Declaration of Kalikoʻonalani D. Fernandes at ¶¶ 4–7.
