carry legislation was associated with a change in the rates of homicide and other violent crime.

The study set the rate of violent crime as the study's dependent variable. The study then plugged in a variety of independent values such as introduction of "shall issue" legislation in order to determine whether permissive carry laws impact violent crime rates. Independent variables are put in an equation to measure the effect that they have (or whether they have a relationship) on the dependent variable. Here, the independent variables were measured for violent crime to produce an event rate. An event rate is a measure of how often a particular statistical event occurs within a dependent value.

A regression model was then used to measure the effect of each independent variable on violent crime. Time periods were considered using national and public data relative to the topic aggregated from 1986-2015. Crime, poverty and health statistics along with other associated variables were considered to obtain the overall outcome. The study found that there is no association with legal concealed carry and violence/homicide at any level regardless of the income of the population.

This refutes the study relied upon by the State and their amici. As noted by commentators, their study uses a method highly sensitive to misleading results,

manipulation and relies on cherry-picked sources<sup>1</sup>. The panel correctly found that the State failed to burden to produce sufficient empirical data to justify its laws.
