DECLARATION OF TROY WILLIS

I, Troy Willis, am a plaintiff in the above-entitled action. I make this declaration of my own personal knowledge and, if called as a witness, I could and would testify competently to the truth of the matters set forth herein.

1. I am a current resident of Riverside County, California.

2. I am a law-abiding adult, citizen of the United States, and a retired reserve officer for the Indio Police Department who is not prohibited from owning firearms under the laws of the United States or the state of California. I have never been found by any law enforcement agency, any court, or any other government agency to be irresponsible, unsafe, or negligent with firearms in any manner.

3. I own a semiautomatic, centerfire rifle with a non-fixed magazine, making it a Category 3 “assault weapon” under the latest amendment to the AWCA.

4. I acquired the firearm with the magazine for use in my home for self-defense and other lawful purposes, like hunting, training, and recreation.

5. The AWCA prohibits me from engaging in certain activities with my registered “assault weapon” that are otherwise lawful with any other firearm not classified as an “assault weapon.” But for the AWCA’s restrictions I would engage in such activities.


6. Because the AWCA bars residents from acquiring, transferring, or possessing “assault weapons”, I will be continuously and irreparably harmed by the ongoing deprivation of my individual, fundamental right to possess and use commonly possessed firearms for lawful purposes, including in-home self-defense, without risking criminal prosecution.

7. I would also like to acquire new semiautomatic, centerfire rifles with a detachable magazine, having one or more of the features that is prohibited by the AWCA. Were it not for the prohibitions in the AWCA, and the fear of prosecution for violating it, I would do so.
