On April 18, 2019, Counsel for Defendant emailed Plaintiffs' counsel, stating that Defendants were not able to locate these documents in the supporting papers or Plaintiffs' document productions. As a result of that communication, Plaintiffs realized that they had incorrectly cited the source of these references in a way that indicated Plaintiffs relied on directly on the materials themselves. The source of both references, however, are from the dissenting opinion in *Heller v. District of Columbia*, 670 F.3d 1244, 1287 (D.C. Circuit 2011).

Plaintiffs have, therefore, edited the citation to those references on page 13 of their Memorandum of Points and Authorities in Support of Plaintiffs' Motion for Summary Judgment to reflect the true source of that reference as being from a judicial opinion. As a result of the citations being edited, other citations moved to different pages; thus, the table of contents has been edited to reflect the new page numbers for those citations. Plaintiffs have also deleted citations to those references in support of SUF No. 34 in Plaintiffs' Statement of Uncontroverted Facts and Conclusions of Law in Support of Motion for Summary Judgment.

In reviewing the Memorandum of Points and Authorities in Support of Plaintiffs' Motion for Summary Judgment, Plaintiffs noticed two typographical errors that they have also corrected. They are as follows:
