DECLARATION OF BILL ORTIZ

I, Bill Ortiz, declare:

1. I am the Vice President of Compliance of Turner’s Operations, Inc. d/b/a Turner’s Outdoorsman (“Turner’s”), one of the petitioners in this action. I make this declaration of my own personal knowledge and, if called as a witness, I could and would testify competently to the truth of the matters set forth herein.

2. On April 9, 2020, I submitted a declaration in support of an ex parte application to stay enforcement of the order from the City of Los Angeles requiring Turner’s to close its City of Los Angeles location.

3. On April 13, 2020, I submitted a supplemental declaration in support of an ex parte application to stay enforcement of order from the City of Los Angeles requiring Turner’s to close its City of Los Angeles store.

4. I have personal knowledge of the activities that the Turner’s City of Los Angeles location engages in.

5. All 28 Turner’s stores, including its store located in the City of Los Angeles, sell various medical supplies, including first aid kits from companies such as Adventure Medical Kits and Sightmark, as well as first aid handbooks that provide step-by-step guidance for various medical emergencies. In addition to other first aid and survival supplies, Turner’s also sells replacement water filters used with NDUR Filtration Bottles. A true and correct copy of examples of such products from Turner’s website is attached as Exhibit A.

6. All 28 Turner’s stores, including its City of Los Angeles store, sell various dry food goods.

7. All 28 Turner’s stores, including its store located in the City of Los Angeles, sell safes, lockboxes, and firearm safety devices. A true and correct copy of examples of such products from Turner’s website is attached as Exhibit B.

8. All 28 Turner’s stores, including its City of Los Angeles store, service first responders, including law enforcement, private security, and other emergency personnel, with the sale and/or transfer of necessary equipment such as firearms, ammunition, holsters, tactical

1 clothing like boots, clothing, secure firearm cases, and other equipment.

2 9. The Turner's City of Los Angeles location also maintains a "Large-Capacity
3 Magazine Permit" issued by the California Department of Justice ("DOJ") to engage in the lawful
4 importation and exportation of "large-capacity magazines" for the sole purpose of selling "large
5 capacity magazines" to law enforcement personnel. Turner's maintains approximately 25 to 30
6 "large-capacity magazines" in stock at all time and sells approximately 15 to 20 such magazines
7 monthly.

8 10. The Turner's City of Los Angeles store also maintains inventory of handguns that
9 cannot be sold to the general public because they are not listed on California's "Roster of
10 Handguns Certified for Sale" as required under Penal Code section 32015. The sole purpose for
11 Turner's in maintaining that inventory is to equip law enforcement and other individuals who
12 California exempts from the restriction on such handguns. Turner's maintains approximately 8 to
13 15 "law enforcement only handguns" in stock at all time and sells approximately an equal amount
14 of such handguns monthly. A true and correct copy of an example of a law-enforcement only
15 handgun from Turner's website is attached as Exhibit C.

16 11. All 28 Turner's stores, including its City of Los Angeles store, sell a complete
17 selection of fishing rods, reels, line, tackle, lobster traps, gaffs, landing nets, bait-making rigs,
18 deck boots, "pro-packs" of high-end fishing hooks, and other fishing equipment necessary to
19 harvest fish both recreational and commercial fishing activities. What's more, Turner's City of
20 Los Angeles location is an authorized Licensing Agent for the California Department of Fish and
21 Wildlife, allowing Turner's City of Los Angeles location to issue the required sport fishing
22 license for individuals who wish to lawfully engage in fishing activities in California. Turner's
23 services both recreational and commercial fishing activities with the equipment it sells. A true and
24 correct copy of examples of such products from Turner's website is attached as Exhibit D.

25 12. All 28 Turner's stores, including its City of Los Angeles store, accept for purchase,
26 storage, or surrender to law enforcement, firearms from persons subject to firearm prohibitions
27 such as a temporary or gun violence restraining order. Turner's also purchases firearms from non-
28 immigrant aliens who are leaving the United States and cannot lawfully export their firearm.

1 13. All 28 Turner’s stores, including its City of Los Angeles store, sell various types
2 of hardware, such as screwdriver sets from Dac Tech, multi-tools from SOG and Gerber, and
3 knives for various purposes. A true and correct copy of examples of such products from Turner’s
4 website is attached as Exhibit E.

5 14. All 28 Turner’s stores, including its City of Los Angeles store, provide mailing and
6 shipping services to its customers. Such services are usually for purposes of shipping firearms to
7 manufacturers for purposes of repair, including the repair of firearms for law enforcement
8 officers, first responders, and members of the public. But this also includes the shipping of
9 firearms to out-of-state FFLs for purposes of lawful transfers to a customers’ family members as
10 required by federal law.

11 15. All 28 Turner’s stores, including its City of Los Angeles store, administer state-
12 mandated educational programs. This includes the Firearm Safety Certificate program and the
13 related safe-handling demonstration requirement, both of which are generally required to lawfully
14 purchase a firearm in the state of California.

15 16. Turner’s must generally process all firearm and ammunition transactions through
16 DOJ’s Dealer Record of Sale (“DRoS”) Entry System (“DES”), a web-based service maintained
17 by DOJ. Only California licensed firearm dealers and licensed ammunition vendors generally
18 have access to this system for purposes of reporting the sale, loan, transfer, redemption, and
19 acquisition of firearms to DOJ.

20 17. Turner’s City of Los Angeles location possess a Federal Firearms License (“FFL”)
21 issued by the Bureau of Alcohol, Tobacco, Firearms and Explosives (“ATF”).

22 18. Turner’s City of Los Angeles location possesses a California Firearms Dealer
23 license, Ammunition Vendor License, and “Large-Capacity” Magazine Permit, all issued by DOJ.

24 19. Turner’s City of Los Angeles location possesses a permit for the sale of
25 concealable firearms and a “2nd Hand General” permit issued by the City of Los Angeles, Board
26 of Police Commissioners.

27 20. Among its 28 stores in California, Turner’s City of Los Angeles location is above
28 the company average in terms of sales and volume. Turner’s City of Los Angeles location is also

1 above the company average in terms of consigned and used guns.

2 21. As stated in my prior declaration, Turner's Reseda location holds a secondhand
3 dealer's license jointly approved and issued by City of Los Angeles and California Department of
4 Justice, allowing Turner's Reseda location to engage in activities that include firearms taken in
5 trade, taken in pawn, accepted for sale on consignment, or accepted for auction.

6 22. As stated in my prior declaration, Turner's Reseda location has ceased all
7 operations as of April 2, 2020, as a result of the order issued by the Mayor of Los Angeles and the
8 enforcement of that order by the Los Angeles Police Department threatening civil and/or criminal
9 penalties for not complying.

10 23. Turner's can and, if allowed to operate, would immediately comply with the City's
11 mandatory social distancing protocols.

12 24. As of the date of this declaration, Turner's Reseda location has approximately 30
13 DROS transactions involving a firearm pending with DES. Many of these transactions have
14 already been "approved" and can legally be delivered to their respective customers. But because
15 the City of Los Angeles has ordered Turner's Reseda location to cease all operations, these
16 transactions cannot be completed.

17 25. Once a transaction has been "approved" in DES, the customer must complete the
18 transaction within 30 days. Failure to complete the transaction will require the customer to
19 complete a new ATF 4473 Form and require Turner's to submit a new DROS transaction through
20 DES, effectively requiring the entire transfer process to start over.


21 26. Since being ordered to close by the City of Los Angeles, Turner's Reseda location
22 has been forced to cancel approximately 150 DROS transactions because they were unable to be
23 completed within 30 days.

24 27. Turner's will suffer immediate threat of irreparable harm if forcibly continued to
25 cease all operations at its Reseda location, including furloughing or terminating staff and having
26 no choice but to cease operations at its Reseda location permanently.

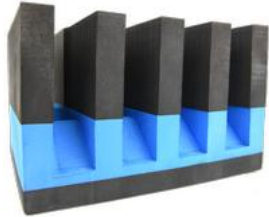
