1. I am a plaintiff in the above-entitled action, and I make this declaration of my own personal knowledge. If called as a witness, I could and would testify competently to the truth of the

- 2. I am currently a tax-paying resident of the city of Morgan Hill, California.
- 3. I am a law-abiding citizen of the United States under the laws of the United States or the state of California. I have never been found by any law enforcement agency, any court, or any other government agency to be irresponsible, unsafe, or negligent with firearms in any manner.
- 4. I lawfully own and possess at least one firearm that is not considered an "antique" under state law that I use for self-defense and other lawful purposes.
- 5. Because I am not a law enforcement officer, peace officer, United States marshal, member of the United States military or National Guard, or a federally licensed firearms dealer, I must comply with Penal Code section 25250 if I discover my firearm has been lost or stolen and report the loss or theft to local law enforcement within five days.
- 6. But as a result of Morgan Hill Municipal Code section 9.04.030, if I believe my firearm is lost or stolen, I would have only 48 hours to report that loss or theft to police and could face prosecution if I fail to do so. I believe this is at odds with California state law, which explicitly gives me five days to report a theft or loss.
- 7. Additionally, if I notice my firearm is missing, I would have to report it to police within 48 hours even if I am not yet sure whether the firearm was lost or stolen or whether I simply misplaced it. I believe this wastes police time and resources, but I risk prosecution under the City's law if I fail to comply.
- 8. Like many law-abiding and responsible gun owners, I would report the theft of my firearm even absent the City's mandate, but because of the City's strict 48-hour timeline and the fact that I cannot be certain what the City will consider to be the date I "reasonably should have known" my firearm was lost or stolen, I fear being prosecuted if I do not know exactly when my firearm was lost or stolen.
