Attached is a copy of the Oral Argument Notice in the above-entitled case. The description, posted on the Court's website contains factual errors. It says:

Appeal from the district court's summary judgment in a 42 U.S.C. § 1983 action arising from the City of San Jose's confiscation and retention of firearms registered to plaintiff and her husband.

It is an undisputed fact of the case that the firearms being retained by the City of San Jose are currently registered solely (and in compliance with California Law) to the Plaintiff/Appellant Lori Rodriguez. Her husband is not a party to this lawsuit. Furthermore, implying that he has guns currently registered to him (though retained by the City of San Jose) is tantamount to a public accusation that Lori's husband still owns firearms and therefore may be committing a crime in California.

The registration status of the firearms at the time of seizure is hardly relevant. In only that respect, is the Notice a true, but still ambiguous statement. I contacted counsel for appellees in this matter to attempt a joint request for correction. They declined to participate in this effort.

A proposed correction:

Appeal from the district court's summary judgment in a 42 U.S.C. § 1983 action arising from the City of San Jose's confiscation and retention of firearms registered to a lawful gun owner who lives with a temporarily prohibited person.
