Attachment to Commercial Division RJI Addendum

Plaintiff's claim for equitable or declaratory relief:

The Attorney General, pursuant to her authority to oversee not-for-profit entities registered in New York, brings this action under the Not-for-Profit Corporation Law, Estates Powers & Trusts Law, and Executive Law addressing abuses in the operation and governance of the National Rifle Association of America, Inc. and against the Individual Defendants for breach of their fiduciary duties, waste, and other wrongful conduct. Plaintiff seeks an order, inter alia, (i) determining that the NRA is liable to be dissolved pursuant to (a) N-PCL § 1101(a)(2) based upon its pattern of conducting its business in a persistently fraudulent or illegal manner, the abuse of its powers, and the failure to provide for the proper administration of its trust assets and institutional funds; and/or (b) N-PCL § 1102(a)(2) because directors or members in control of the NRA have looted or wasted the corporation assets, have operated the NRA solely for their personal benefit, or have otherwise acted in an illegal, oppressive or fraudulent manner; (ii) directing the Individual Defendants to account, make restitution and pay all penalties resulting from the breach of fiduciary duties and their misuse of charitable assets for their own benefit and interests; (iii) removing certain individual defendants from their positions as officers within the NRA; (iv) rescinding related party transactions by the Defendants and directing the Individual Defendants to account for their profits and to pay the NRA up to double the value of each benefit improperly bestowed by such transactions; (v) directing the NRA to account for its official conduct with respect to management of the NRA's institutional funds; and (vi) ordering restitution from the Individual Defendants to recover illegal, unauthorized or ultra vires compensation. reimbursements, benefits or amounts unjustly paid to the Individual Defendants.
