The Court, having considered the Stipulation of the parties, plaintiffs Adam Brandy, et al. (“Plaintiffs”), and defendants County of Los Angeles, Sheriff Alex Villanueva, sued in his official capacity, and Barbara Ferrer, sued in her official capacity (“County Defendants”) filed on August 25, 2020, and finding good cause appearing, hereby approves of the parties’ stipulation, and hereby ORDERS as follows:
