PRELIMINARY ORDER OF
CRIMINAL FORFEITURE

WHEREAS, in the Indictment, the United States sought forfeiture of all right, title and interest in firearms and ammunition of Defendant MORAD MARCO GARMO (“Defendant”), pursuant to, *inter alia*, 18 U.S.C. § 924(d) and 28 U.S.C. § 2461(c), as properties involved in the violation of 18 U.S.C. §§ 922(a)(1)(A), 923(a), 924(a)(1)(D) and 2, as charged in the Indictment; and

WHEREAS, on or about September 15, 2020, Defendant pled guilty before U.S. Magistrate Judge Mitchell D. Dembin to Count One of the Indictment, which plea included consents to the forfeiture allegations of the Indictment, including forfeiture of the following:

- (1) 5,360 ROUNDS OF 7.62 MM AMMUNITION (SEIZED AS ITEM #650)
- (2) 25 ROUNDS OF FEDERAL 9MM AMMUNITION (SEIZED AS ITEM #78)

17 And WHEREAS, on September 29, 2020 this Court accepted the guilty plea of
18 Defendant; and

19 WHEREAS, by virtue of the facts set forth in the plea agreement and forfeiture
20 addendum, the United States has established the requisite nexus between the forfeited
21 and surrendered firearms and ammunition and the offense; and

22 WHEREAS, by virtue of said guilty plea, the United States is now entitled to
23 possession of all the afore-described firearms and ammunition, pursuant to 18 U.S.C.
24 § 924(d), 28 U.S.C. § 2461(c), and Rule 32.2(b) of the Federal Rules of Criminal
25 Procedure; and

26 WHEREAS, pursuant to Rule 32.2(b), the United States having requested the
27 authority to take custody of the firearms and ammunition which are hereby found
28 forfeitable by the Court; and

1 WHEREAS, the United States, having submitted the Order herein to the
2 Defendant through his attorney of record, to review, and no objections having been
3 received;

4 Accordingly, IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

5 1. Based upon the guilty plea of the Defendant, the United States is hereby
6 authorized to take custody and control of the following firearms and ammunition, and
7 all right, title and interest of Defendant MORAD MARCO GARMO in the following
8 properties are hereby forfeited to the United States for disposition in accordance with
9 the law, subject to the provisions of 21 U.S.C. § 853(n):

2 2. The aforementioned forfeited assets are to be held by the United States
3 Alcohol, Tobacco, Firearms and Explosives in its secure custody and control.

4 3. Pursuant to Rule 32.2(b) and (c), the United States is hereby authorized
5 to begin proceedings consistent with any statutory requirements pertaining to
6 ancillary hearings and rights of third parties. The Court shall conduct ancillary
7 proceedings as the Court deems appropriate only upon the receipt of timely third
8 party petitions filed with the Court and served upon the United States. The Court
9 may determine any petition without the need for further hearings upon the receipt of
10 the Government's response to any petition. The Court may enter an amended order
11 without further notice to the parties.

12 4. Pursuant to the Attorney General's authority under Section 853(n)(1) of
13 Title 21, United States Code, Rule 32.2(b)(6), Fed. R. Crim. P., and Rule G(4) of the
14 Supplemental Rules for Admiralty or Maritime Claims and Asset Forfeiture Actions,
15 the United States forthwith shall publish for thirty (30) consecutive days on the
16 Government's forfeiture website, www.forfeiture.gov, notice of this Order, notice of
17 the United States' intent to dispose of the properties in such manner as the Attorney
18 General may direct, and notice that any person, other than the Defendant, having or
19 claiming a legal interest in the above-listed forfeited properties must file a petition
20 with the Court within thirty (30) days of the final publication of notice or of receipt of
21 actual notice, whichever is earlier.

22 5. This notice shall state that the petition shall be for a hearing to
23 adjudicate the validity of the petitioner's alleged interest in the property, shall be
24 signed by the petitioner under penalty of perjury, and shall set forth the nature and
25 extent of the petitioner's right, title or interest in the forfeited property and any
26 additional facts supporting the petitioner's claim and the relief sought.

27 6. The United States shall also, to the extent practicable, provide direct
28 written notice to any person known to have alleged an interest in the properties that


1 are the subject of the Preliminary Order of Criminal Forfeiture, as a substitute for
2 published notice as to those persons so notified.

3 7. Upon adjudication of all third-party interests, this Court will enter an
4 Amended Order of Forfeiture pursuant to 21 U.S.C. § 853(n) as to the above-
5 referenced assets, in which all interests will be addressed.

6 8. Pursuant to Rule 32.2(b)(4), this Order of Forfeiture shall be made final
7 as to the Defendant at the time of sentencing and is part of the sentence and included
8 in the judgment.

9 IT IS SO ORDERED.
