4		safekeeping?
5		A. May have been, I don't specifically recall.
6	Q.	Okay. Did you have any training, any instruction
7		at the police training academy on the community
8		caretaking function?
9		A. May have been. I don't specifically recall.
10	Q.	Okay. Did you have any training or education at
11		the police training academy on domestic violence
12		issues?
13		A. Yes.
14	Q.	What do you recall about that?
15		A. I believe in 1993 the domestic violence laws
16		had just recently been enacted and the mandatory
17		arrest was part of that. So that was a new topic
18		for law enforcement across the state that would be
19		rolled out, I believe that was in 1992, if I
20		remember correctly.
21	Q.	Do you recall anything else about the instruction
22		or education on domestic violence issues at the
23		training academy?
24		A. Specifically, no.
25	Q.	Did you receive any instruction at the police

1		first-line supervisor what's expected. It was
2		just general curriculum.
3	Q.	Was it along the lines of administrative
4		functions, or did you actually get into
5		substantive law enforcement issues like arrest,
6		detaining people, that sort of thing?
7		A. I don't recall the specific curriculum.
8	Q.	Okay. Do you have any of those materials still
9		around from those courses?
10		A. I can check. I may in a bin in my basement
11		with I don't know, various things that have
12		been accumulated over the last 25 years.
13	Q.	Any idea when the last time you looked at those
14		materials?
15		A. No idea if they're even there.
16	Q.	The training with the DEA, you said it had
17		something to do with drug enforcement?
18		A. Yes, sir.
19	Q.	Was that it, generally, just drug enforcement
20		specifically?
21		A. Yes. I was assigned to the Drug Enforcement
22		Administration from roughly 2007 to 2010.
23	Q.	Okay. The short-term schools you took that you
24		referred to, from a day to less than a week, did
25		any of them deal with when it's appropriate to

2		A. I don't recall.	
3	Q.	Okay. Did any of them deal with when it is	
4		appropriate to seize any kind of property without	
5		a warrant or court order?	
6		A. I don't specifically recall.	
7	Q.	Did any of them deal with seizing weapons for	
8		safekeeping?	
9		A. I don't specifically recall.	
10	Q.	Did any of them deal with the community caretaking	
11		function?	
12		A. I don't recall.	
13	Q.	Did any of them deal with requiring people to have	
14		psychiatric evaluations?	
15		A. I don't recall.	
16	Q.	In 2015 approximately how many police officers	
17		were there in Cranston, employed by Cranston?	
18		A. I think we're authorized for 153. It is some	
19		number less than that. Generally we're within 10	
20		or 15 of that number.	
21	Q.	All right. So somewhere between 140 and 150,	
22		somewhere in that range?	
23		A. That's fair to say.	
24	Q.	So, were they assigned to particular shifts?	
25		A. Sure. Many different assignments within the

1		A. I think it's fair to say that they could be	
2		one or the other or both.	
3	Q.	Okay. When did you first hear of the community	
4		caretaking function?	
5		A. I hear about it periodically. It's	
6		something to me it's synonymous with public	
7		safety. I think the Community Caretaking Doctrine	
8		that's referred to if you depending on what you	
9		read.	
10	Q.	Okay. Did you learn about it in any formal	
11		education that you have had?	
12		A. I may have. I don't recall where I learned	
13		it specifically.	
14	Q.	All right. Did you read about it in any materials	
15		you received?	
16		A. May have. I try I take pride in	
17		self-education, you know, sometimes with different	
18		court decisions, whatnot, you know, I try to read	
19		those, keep up on current events. Sometimes the	
20		lack of formal training or in-service training on	
21		those type of things, so I do a lot of reading.	
22	Q.	Has the Cranston Police Department had any	
23		in-service let me back up. You referred to	
24		in-service training, what do you mean by	
25		in-service training?

Α. So we have in-service training periodically throughout the year for different topics where our training division schedules a block of time, whatever it is, to periodically review issues that they feel need to be refreshed or maybe to review something, a new law, a new technique, best practice, the department is going to adopt mandatory in-service training, the domestic violence -- the law mandates we receive X amount of training per year. I believe driving while intoxicated law mandate we have recertification every year. We also have roll call training which takes place at the change of shifts when we have the officers there, we review different topics, updates on policies, we consider that a training. We have a software database called Power DMS where policy updates are disseminated, there is also materials loaded in there that officers are required to review that are considered trainings. Okay. Do you know whether the Cranston Police Department has had any in-service training on the community caretaking function? Well, let me say this, I believe we've had --Α. let me -- no, I don't believe we had any

specifically called training on the Community

1		Caretaking Act, so the answer would be no.	
2	Q.	Well, have you had any in-service training that	
3		covered the community caretaking function,	
4		regardless of whether or not the title of the	
5		instruction was community caretaking function?	
6		A. I believe that we've had in-service training	
7		and trainings offered trainings put on by	
8		outside agencies that were offered to our officers	}
9		that covered mental health topics.	
10	Q.	Okay. And you think that the mental health	
11		training would have covered the police's authority	-
12		under the community caretaking function?	
13		A. I would believe so.	
14	Q.	All right. Has the community caretaking function	
15		come up in any other training other than mental	
16		health?	
17		A. Not that I can recall right now.	
18	Q.	Okay. We have used the phrase in this litigation	
19		seizure of firearms for safekeeping, does that	
20		come under the community caretaking function, or	
21		is there a different authorization for that?	
22		MR. CUNNINGHAM: Objection.	
23		MR. LYONS: If you understand what I	
24		mean.	
25	Q.	Let me back up. Let's break it down. Have you

2		seizure of firearms?
3		A. Yes.
4	Q.	What's your understanding of seizing firearms for
5		safekeeping?
6		A. My understanding relative to the Cranston
7		Police Department is when situations arise where
8		we're dealing with firearms, if we feel that the
9		circumstances that exist at the time create a
10		danger relative to the firearms, create a danger
11		to the public, or to any member of the public, we
12		would take the firearms, hold them for
13		safekeeping, if that explain your question.
14	Q.	Okay. I'm referring specifically to the
15		circumstance that does not involve a criminal
16		investigation; okay?
17		A. Yes, sir.
18	Q.	All right. So when the Cranston Police Department
19		seizes a firearm for safekeeping, and it's not a
20		criminal investigation, is it your understanding
21		that its authority to do that arises from the
22		community caretaking function?
23		A. Yes.
24	Q.	Okay. Do you know if the Power DMS program has
25		any materials that discuss the community

2		A. Off the top of my head, I do not know.	
3		There's hundreds of documents in the Power DMS	
4		Just to further answer that, that also encompasses	
5		our policy database in the Power DMS, additional	
6		trainings and whatnot.	
7	Q.	When you say policy database, like the general	
8		orders?	
9		A. Yes, sir.	
10	Q.	The roll call training during a prior	
11		deposition of a younger police officer, I	
12		analogized it to the scenes in Hill Street Blues,	
13		and the reference went right over his head.	
14		A. I can understand that.	
15		MR. CUNNINGHAM: Please don't tell me	
16		it goes over your head.	
17		(OFF THE RECORD)	
18	Q.	But is that the kind of thing where the police are	
19		all assembled either at the beginning or end of a	
20		shift, and the supervisor gives them updates on	
21		something?	
22		A. Yes.	
23	Q.	Is that the kind of thing we're talking about	
24		here?

15	Q.	Okay. Are you aware of any Rhode Island statute	
16		that recognizes the community caretaking function?	ı
17		A. I believe it's my opinion that there was	
18		recently a law passed last year, I believe, under	
19		Title 40.1 that memorializes the I don't	
20		believe it uses those words, but I believe it	
21		memorialized the concept, gives the authority to

9		probably the most recent one I remember.	
10	Q.	Okay. Are you aware of any court decisions	
11		recognizing the community caretaking function, and	L
12		stating that it authorizes police to seize	
13		property, including firearms, from a person's	
14		residence?	
15		A. Off the top of my head, no.	
16	Q.	Are you aware of any court decision recognizing	
17		the community caretaking function and stating it	
18		authorizes police to require someone to leave	
19		their residence and go for a psychiatric	
20		evaluation?	
21		A. No.	
22	Q.	Other than what we've talked about so far, have	
23		you had any other training on the seizing of	
24		firearms for safekeeping?	
25		THE WITNESS: Specific to that

2		in-service training, and I'm not sure where it
3		went, it listed several specific topics.
4		A. Right. Domestic violence, mental health,
5		intro to safety net, 2011.
6	Q.	Correct. Just so we're clear, that's Exhibit 14
7		you're looking at right now?
8		A. Yes.
9	Q.	So what I'm getting at is whenever there is record
10		of in-service training similar to Exhibit 14,
11		would it list the topics that were presented?
12		A. I would assume that the training lieutenant
13		keeps the curriculum of what's presented when, to
14		who.
15	Q.	Okay. In other words, I should ask the training
16		lieutenant for whatever records there are of any
17		presentations of in-service training dealing with
18		search and seizure law?
19		A. Yes.
20	Q.	Okay. If you look at, going back to Exhibit 8, if
21		you go to Page 10, please. There's a slide
22		entitled Exceptions to the Search Warrant
23		Requirement; do you see that?
24		A. Yes.
25	Q.	There are ten items listed; do you see those?

2	Q.	Number 10 says Community Care; do you see that?	
3		A. Yes.	
4	Q.	Is that the community caretaking function we've	
5		been discussing?	
6		A. Yes.	
7	Q.	So that would be an exception to the search	
8		warrant requirement?	
9		A. Yes.	
10	Q.	Then if you will go to Page 32, there's one slide	
11		which is entitled Community Caretaking Function;	
12		do you see that?	
13		A. Yes.	
14	Q.	Okay. Do you recall seeing this slide in any	
15		presentation at the Cranston Police Department?	
16		A. I don't recall it specifically, no.	
17	Q.	Okay. It refers to one case, if you see, State	
18		versus Roussell; do you see that?	
19		A. Yes.	
20	Q.	It says, Trooper investigates erratic operation of	
21		motor vehicle by opening passenger side door of	
22		motor vehicle. Makes impaired operator	
23		observations. Not a search because officer	
24		engaged in community caretaking; do you see that?	
25		A. Yes.

1	Q.	Is that the case you were recalling previously
2		that dealt with the community caretaking function?
3		A. No. The facts were about a seizure of some
4		marijuana by a trooper, they were investigating a
5		motor vehicle accident. It was a traffic tribunal
6		issue.
7	Q.	You don't recall the name of the case, though?
8		A. That was the most recent one I saw.
9	Q.	Have you ever read State versus Roussell?
10		A. I don't know, I couldn't tell you, unless I
11		read some more facts. I don't recall reading it.
12	Q.	Does this slide describe your understanding of the
13		community caretaking function?
14		A. Part of it.
15	Q.	Do you know if you have seen any other
16		presentation that sets forth the rest of your
17		understanding of the community caretaking
18		function?
19		MR. CUNNINGHAM: Objection.
20		A. I don't recall off the top of my head right
21		now.
22	Q.	Okay. The first part says,
23		counselor/midwife/emissary/taker - tasks not
24		involved with apprehension of alleged criminals;
25		do you see that?

Does that part describe the police officer's 2 Q. community caretaking function? 3 To me it means the initial intent of the act 4 Α. taken by the officers wasn't to make an 5 apprehension of an alleged criminal or to 6 7 investigate a crime. 8 So with respect to the case they made the 9 little snippet of, I think the point they're 10 trying to make in the training was the trooper had opened the passenger side door of the motor 11 12 vehicle to make observations. They deemed it was 13 not a search because he was checking on the well-being of the erratic operator. 14 15 Do you know if there's any Rhode Island decisions 0. dealing with the community caretaking function 16 17 apart from those dealing with the operation of a 18 motor vehicle? 19 Α. 10	Q.	Do you own any firearms yourself?

13		A. Glock model 43, .9 millimeter, that's it.	
14	Q.	That's it?	
15		A. That's it.	
16	Q.	Okay. Have you ever had your firearm seized?	
17		A. No.	
18	Q.	Have you ever had the police come to your house	
19		for a domestic incident?	
20		A. Never.	
21	Q.	Have you ever gone to a police officer's house for	
22		a domestic incident?	
23		A. Yes.	
24	Q.	Okay. How many times?	
25		A. At least once that I can remember twice
