On November 6, 2020, Petitioner filed a motion for return of property (ECF No. 122) and a petition in opposition to forfeiture (ECF No. 121) based on identical pleadings. Specifically, the parties request that the United States be ordered to file a response to the petition no later than three weeks prior to the continued hearing.
