- 6. Therefore, plaintiffs' counsel is seeking a fifth extension to serve defendant Ghost America LLC, dba Ghostguns.com. for an additional period of time up to and including **January 29,2021**. And, we hope to be able to accomplish that service via the Secretary of State as soon as we are in receipt of this Court's order authorizing such service.






