1 I, BRANDON STORMENT, declare that I am an attorney at law duly licensed to  
2 practice before all the Courts of the State of California, and I am a partner in the law firm of  
3 Barr & Mudford, LLP, attorneys of record for plaintiffs herein.

4 Plaintiffs caused to be filed in this court their *Complaint for Damages* on  
5 November 14, 2019 against the above-named thirteen defendants.

6 Plaintiffs' counsel has served all defendants except Ghost America LLC, dba  
7 Ghostguns.com.

8 The process server retained by plaintiffs' counsel to serve said defendant made nine  
9 unsuccessful attempts to serve the registered agent for service at the address identified with the  
10 Secretary of State. It appears the agent is actively evading service. (The details of the attempts

1 to serve are outlined more fully in the application plaintiffs filed on September 22, 2020 to  
2 obtain this Court's permission to accomplish service via the Secretary of State, a copy of which  
3 is attached hereto as **Exhibit A** for reference.)

4  
5 5. Consequently, on September 22, 2020 plaintiffs' counsel filed an application with  
6 this Court to serve defendant Ghost America LLC, dba Ghostguns.com via the Secretary of State  
7 consistent with Cal. Corp. Code § 17701.16(c). The application has not been ruled on, yet.

8 6. Therefore, plaintiffs' counsel is seeking a fifth extension to serve defendant Ghost  
9 America LLC, dba Ghostguns.com. for an additional period of time up to and including **January**  
10 **29, 2021**. And, we hope to be able to accomplish that service via the Secretary of State as soon as  
11 we are in receipt of this Court's order authorizing such service.

12 I declare under penalty of perjury, under the laws of the State of California, that the

18 I, ESTEE LEWIS, declare:

19 I am an attorney at law duly authorized to practice before all courts of the State of  
20 California and an associate of the law firm of Barr & Mudford, attorneys of record for plaintiffs.

21 The matters which are embraced within my Declaration are matters within my personal  
22 knowledge and if called upon I would and could competently testify as follows:

23 1. Plaintiffs, by and through their counsel of record, respectfully request that this  
24 Court issue an Order permitting Plaintiffs to serve defendant Ghost America LLC dba  
25 Ghostguns.com, a Limited Liability Corporation, via the California Secretary of State.

26 2. This request is based on this Declaration, Exhibits A and B to this Declaration, the  
27 Complaint for Damages on file with this Court, and any additional records or evidence on file  
28 with this Court.

1           3. Defendant Ghost America LLC dba Ghostguns.com is a properly named  
2 defendant, and this court has subject matter jurisdiction over this case, since the amount of the  
3 claims exceeds \$25,000.00. (CCP §88.)

4           4. Further, venue is proper in this court because several of the Defendants,  
5 including, RYAN BEEZLEY and BOB BEEZLEY d/b/a RBTACTIALTOOLING.COM, and  
6 DEFENDANT JAMES TROMBLEE, JR., d/b/a USPATRIOTARMORY.COM are California  
7 residents and/or California Corporations who at all relevant times reside in and/or have their  
8 principal place of business in the City of Apple Valley, County of San Bernardino, State of  
9 California. (CCP §395 et seq.).

11           5. Barr & Mudford verified with the California Secretary of State that Defendant  
12 Ghost America LLC dba Ghostguns.com is a registered limited liability corporation (LLC). As  
13 such, it is required to designate an agent for service of process with the Secretary of State. (Corp.  
14 Code §17701.13(a)(2)). Here, Ghost America LLC designated Kyle Martin as its agent for  
15 service of process with the Secretary of State and provided an address of 23470 Cambridge  
16 Road, Yorba Linda, CA 92887. (A true and correct copy of the Secretary of State Registration  
17 and Statement of Information is attached hereto and incorporated herein as **Exhibit A.**)

19           6. However, Kyle Martin, the designated agent, cannot be located and service cannot  
20 be effected at the listed address. Reasonable diligence has been exercised to accomplish service  
21 by means established by the Code. But the designated agent, Kyle Thomas Martin, appears to be  
22 actively evading service. Bryan Canas, the process server hired by Barr & Mudford to serve  
23 defendant Ghost America LLC dba Ghostguns.com, has made the following efforts to locate and  
24 serve Mr. Martin, at different times of the day and different days of the week, all to no avail:
