**STIPULATION TO

(the “NRA”), Wayne LaPierre (“LaPierre”), and John Frazer (“Frazer”) (collectively “Stipulating Defendants” and collectively with Plaintiff, the “Parties”), through their respective counsel.

WHEREAS, Stipulating Defendants’ time to answer or otherwise respond to the complaint in the above-captioned matter is currently set for February 22, 2021; and

WHEREAS, Defendants LaPierre and Frazer are scheduled to testify on behalf of Defendant NRA in a separate proceeding on February 22, 2021, and the Parties have agreed to adjourn Stipulating Defendants’ answer deadlines to accommodate such testimony;

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, by and between the Plaintiff and Stipulating Defendants, that the deadline for each of Defendant NRA,

Defendant LaPierre, and Defendant Frazer to answer or otherwise respond to the complaint shall be and is hereby extended until February 23, 2021.

IT IS FURTHER AGREED AND STIPULATED that this stipulation can be executed in counterparts and by using electronic, scanned or telefaxed signatures, with the same effect as original signatures.
