ORDER ASSIGNING COORDINATION MOTION JUDGE

The Honorable William D. Claster, Judge of the Superior Court of California, County of Orange, is hereby assigned pursuant to Code of Civil Procedure Section 404 and Rule 3.524, California Rules of Court, to sit as coordination motion judge to determine whether the actions over which this Court has jurisdiction are complex, and if so, whether coordination of the included actions enumerated above is appropriate. If the coordination motion judge grants the petition for coordination, he must (1) recommend a particular superior court for the site of the coordination proceedings, and (2) select the reviewing court having appellate jurisdiction if the actions to be coordinated are within the jurisdiction of more than one reviewing court.

Pursuant to Section 404.5 and Rule 3.515, pending the decision on the petition for coordination, the coordination motion judge may stay any action being considered for, or affecting an action being considered for, coordination.

Pursuant to Rule 3.524, the clerk of each court in which an included action is pending is directed to file this order in the included action.

Pursuant to Rules 3.501(17) and 3.524, all documents required to be submitted to the coordination motion judge shall be transmitted to him at the court address designated below:




