**ORDER SETTING PRELIMINARY TRIAL
CONFERENCE**

Counsel and all persons representing themselves must come to the conference prepared to discuss all matter specified in this order.

1 The items on the agenda pursuant to Rule 3.541(a) are as follows:

- 2 (1) Appointment of liaison counsel in accordance with Rule 3.506;
- 3 (2) Establishment of a timetable for filing motions other than discovery motions;
- 4 (3) Establishment of a schedule for discovery.
- 5 (4) Provision for a method and schedule for submitting preliminary legal questions to
- 6 expedite disposition of the coordinated actions;
- 7 (5) Establishment in class actions of a schedule, if practicable, for prompt
- 8 determination of matters pertinent to the class action issue;
- 9 (6) Establishment of a central depository or depositories to receive and maintain for
- 10 the parties' inspection evidentiary material and specified documents that these
- 11 rules do not require to be served upon all parties; and
- 12 (7) Scheduling of further pretrial conferences if appropriate.
- 13 (8) Filing and service of documents in a central electronic depository. (Code of Civ.
- 14 Proc., §1010.6; Rule 3.751.)

16 Not later than 08.06.21, each party must serve on all other parties and file with the
17 coordination trial judge a memorandum setting forth each parties' views and suggestions as to
18 each item on the agenda, including proposed stipulations with respect to issues of fact and law
19 and other matters.

20 At the preliminary trial conference, the coordination trial judge will also consider,
21 pursuant to Rule 3.541 (b), whether to

- 22 (1) Order any coordinated action transferred to another court pursuant to Rule
- 23 3.543;
- 24 (2) Schedule and conduct hearings, conferences, and a trial or trials at any site within
- 25 the state he or she deems appropriate with due consideration to
- 26 (a) convenience of the parties, witnesses, and counsel;
- 27 (b) relative development of the actions and the work product of counsel;
- 28 (c) efficient use of judicial facilities and staff; and
