Hearing held. Pursuant to the agreement of the parties, attorney Amy K. VanZant from the law firm of Orrick, Herrington, & Sutcliffe and attorney Sean A. Brady from the law firm of Michel & Associates are appointed as liaison counsel pursuant to California Rule of Court 3.501 (12).
