While the related case, O'Sullivan v. Ghost Gunner, Inc., et al., arises from a different set of facts than the two coordinated wrongful death and personal injury actions currently before this Court, it concerns the exact same legal issues. Plaintiffs in all three cases allege causes of action for negligence, negligent entrustment, public nuisance, and alleged violation of several consumer protection statutes (Bus. & Prof. Code § 17200/17500). All cases involve the alleged assembly of semi-automatic rifles using a variety of component parts, including unfinished lower receivers of purportedly unknown origin, which were criminally misused to cause Plaintiffs' respective injuries. All Plaintiffs seek to hold various manufacturers, distributors and retailers of unfinished lower receiver parts and kits – which were legal to manufacture and sell – liable for the criminal conduct of third parties. And all Plaintiffs are attempting to apply a market share liability theory against Defendants, which is based on the false assumption that the origin of the products cannot be identified and that the products are fungible goods. Plaintiffs market share liability theory, however, fails as a matter of law for two reasons. First, Defendants' products are demonstrably not fungible and, second, Plaintiffs fail to allege that Defendants constitute the universe of manufacturers/vendors of the products. The Defendants in all three cases are mostly the same (with some additional defendants named in the O'Sullivan matter), and the legal defenses will likely be nearly identical in all three actions.
