2 and Plaintiffs, by and through their respective counsel of record, hereby stipulate:

3 WHEREAS, on June 17, 2021, Plaintiffs filed their complaint alleging five causes of  
4 action against eighteen named defendants;

5 WHEREAS, on August 16, 2021, the Court issued an Order staying the case until  
6 September 30, 2021, to permit Plaintiffs time to serve the large number of named defendants and  
7 to avoid having multiple responsive pleading deadlines for those defendants;

8 WHEREAS, Defendants filed a petition to coordinate this matter as an Add-On case with  
9 the *Ghost Gunner Firearms Cases*, Judicial Council Coordination Proceeding No. 5167, and  
10 Defendants jointly requested with Plaintiffs that this Court maintain the previous stay until that

17 WHEREAS, this Court ordered the Plaintiffs and the Defendants who have appeared to  
18 propose a briefing schedule for responsive pleadings by December 6, 2021;

19 WHEREAS, after meeting and conferring, Plaintiffs and the Defendants who have  
20 appeared agree that it would benefit the Court and all parties for the Court to hold a Case  
21 Management Conference with all parties before establishing deadlines in this matter;

22 THEREFORE, Plaintiffs and the Defendants who have appeared jointly request that this  
23 Court set a Case Management Conference for all parties in order to set a briefing schedule for  
24 responsive pleadings and all other case deadlines that may be relevant at this time.





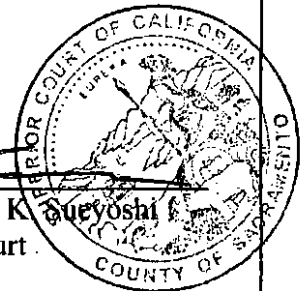
