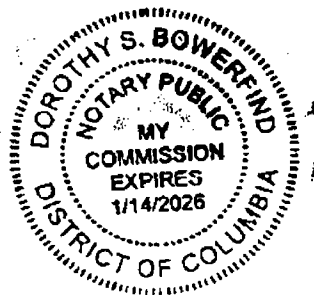
4. I am familiar with the facts of the above-captioned action. The interests of the client and of judicial economy support my admission *pro hac vice*.
