1                                   **JOINT CASE MANAGEMENT CONFERENCE STATEMENT**

2   **I.       UPDATE OF CASE STATUS SINCE LAST CMC**

3           The Parties jointly submit this Case Management Conference Statement to update the  
4   Court on events since the last conference.

5   **II.     DISCOVERY AND PROPOSED PROCESS FOR FIREARMS INSPECTION AT**  
6   **TEHAMA COUNTY SHERIFF'S DEPARTMENT**

7           Since the last status conference, the Parties have jointly confirmed May 24, 2022 for an  
8   inspection of the firearms, some of which allegedly incorporate parts of the sort that Defendants  
9   make/sell, in the possession of the Tehama County Sherriff's Office (TCSO), beginning at 9 a.m.  
10   PST. The inspection will be conducted at the Sherriff's Office in Redding, California. The  
11   Parties anticipate videotaping the inspection, including to visually observe the handling and  
12   testing of the firearms by the other parties and their experts. A subset of the Parties intends to  
13   perform limited disassembly and testing of the firearms to the extent permitted. TCSO counsel  
14   has notified the parties that the following firearms/parts shall be available for inspection:

- 17           • Mossberg 500A Pump
