SECOND AMENDMENT TO ORDER Re: ARONSON DOCUMENTS

This order reaffirms and supplements an Amended Order dated April 12, 2022 relating to the OAG's motion to compel disclosure of documents in the files of the NRA's accounting firm, Aronson, LLC ("Aronson"). The prior order related to documents in the possession of Aronson that were withheld at the direction of the NRA. This order extends to reducted documents.

The documents that are the subjects of this motion are listed on the spreadsheet accompanying this order. The spreadsheet which is incorporated herein has been amended to set forth the Special Master's ruling on each document (*see* columns K and L).

The elements of the attorney-client privilege are 1) a communication, 2) made between privileged persons, 3) in confidence, 4) for the purpose of obtaining or providing legal assistance for the client (*see* Restatement [Third] of the Law Governing Lawyers §68 [2000]). The communication need not be limited to the client and its attorney. It could extend to communications involving certain agents of either privileged person (such as accountants,

economists and physicians) who may be consulted so that the attorney may knowledgeably advise

the client (see United States v Kovel, 296 F. 2d 918, 922 [2d Cir. 1961]). Confidential

communications from the client to such experts, made with the view toward receiving legal

services from the attorney, come within the privilege. Notably, to limit privilege problems, the

attorney rather than the client, typically retains the expert, informs the expert of relevant facts and

receives the expert's findings.

The privilege extends only to communications made with the intent and reasonable

expectation that they will not be disclosed to anyone outside the attorney-clients relationship (see

People v Balge, 59 AD 2d 307, 309 [4th Dept 1977]). However, if the information communicated

privately to the attorney was intended to be conveyed to others, such as in a tax return, the general

rule is that no privilege will attach (see, e.g. United States v Bohonnon, 628 F Supp 1026, 1029 [D

Conn] [tax return], aff'd 795 F 2d 79 [2d Cir 1985]). But, where the client intended to disclose to

third-parties only the substance of the discussion held with the attorney, it does not mitigate the

privilege (see In re Vanderbilt (Rosen-Hickey), 57 NY 2d 66, 77 [1982]).

With these principles in mind, the Special Master, has determined that virtually all of the

documents required to be produced on grounds of waiver were protected. The emails show the

NRA and its counsel took care to confine communications intended to provide the NRA with tax

law advise, to privileged persons. Throughout development of the tax strategy, the NRA and its

counsel excluded Aronson, the NRA's accountants and auditors (not a privileged person), thereby

protecting the privilege. Having formulated a tax strategy that contained the legal guidance

received, the NRA forwarded the results of the work along with privileged communications from

which it had shielded Aronson during development of those results. Disclosure of the latter to

Aronson has resulted in waiver and those documents shall be produced (see e.g. Bates Nos. 5863,

5491).

The NRA also seeks to withhold non-privileged business records it provided to Aronson

(see, e.g. Bates Nos. 169, 685, 5439), replies to auditor inquiries (see Bates Nos. 6104, 5216) and

documents prepared by Aronson or collected by it in connection with Aronson's tax preparation

and audit work (see Bates Nos. 8574, 842, 846). These documents are not privileged and shall be

produced.

The documents in the spreadsheet with the designation "P" in column "K" may be withheld

or produced with redactions, as appropriate. All other documents shall be produced.
