1 This Court, having reviewed the Joint Status Report of the parties filed on July 16, 2018,
2 finds good cause and will hereby ORDER as follows:

3 In furtherance of this Court's Order Staying Discovery entered on March 12, 2018
4 (Dkt. No. 80), and pursuant to the agreement and request of the parties set forth in the Joint Status
5 Report filed on July 16, 2018, the stay presently in place in this action (Dkt. No. 82) is extended,
6 pending the outcome of the California Attorney General's appeal of the grant of a preliminary
7 injunction in *Duncan v. Becerra*, Ninth Circuit Court of Appeals Docket No. 17-56081, through
8 and until the date of the Scheduling Conference specified below, and subject to any party's ability
9 to inform this Court of any developments that would warrant a lifting of the stay at an earlier date.

10 The current Scheduling Conference presently set for hearing on July 30, 2018 is hereby
11 VACATED. A new Scheduling Conference shall be held on **September 24, 2018** at 1:30 p.m., or
12 earlier as this Court may allow upon the application of any party.
